### **ELECTION NOTICE AND SCHEDULE**

#### **1. Introduction.**

A Student Council provides an opportunity for students to engage in a structured partnership with teachers, students and management in the operation of their university. Lyngdoh Committee (2006) made certain recommendations and accepted by the Hon'ble Supreme Court of India for implementation. It says, "Universities and colleges across the country must ordinarily conduct elections for the appointment of students to student representative bodies" (Section 6.1.1).

#### **2. About the Student Council.**

The KR Mangalam University Student Council is a student body that represents the interests of KR Mangalam University students and aims to enrich life at KR Mangalam University for all stakeholders and formulates solutions to any issues they may face in collaboration with Student Affairs Advisory Body and KR Mangalam University administration.

#### **3. Objectives of the Student Council.**

The objectives of the Students Council are:

- a. To increase student involvement and University pride.
- b. To develop leadership abilities among the youth of today and well informed, responsible, honest, concerned and active citizenry of tomorrow.
- c. To uphold the interest of students and encourage them to contribute to the sustenance of democratic values in the University by simultaneously aiming at self-transformation, empowerment and positive involvement in University life.
- d. To enhance understanding within and between groups through interaction and communication.
- e. To increase avenues of cooperation among the administration, faculty and students.

- f. To promote respect for law and order and general welfare of the University and the community.
- g. To assist in organizing and developing different activities within the University and ensuring participation in other universities.

**4. General Body.**

All students of KR Mangalam University shall constitute its General Body. All the elected representatives shall constitute the Student Council.

**5. Student Council.**

The Student Council shall be elected by the General Body. The term of office shall be one academic year for each of the Student Council members. The Council shall have the following Office Bearers:

- a. President
- b. Vice President
- c. General Secretary Cultural Activities
- d. General Secretary Sports Activities
- e. General Secretary Hostel Affairs
- f. General Secretary Outreach and Extension Activities
- g. Editor-in-Chief of Student Editorial Board

**6. Procedure for Election.**

Elections will be conducted according to notified schedule inviting open applications from candidates of all Schools on the basis of their performance in curricular and co-curricular activities, achievements & accomplishments, leadership and managerial qualities, discipline and conduct in the preceding years at the University or in their previous institutions, the potential for contribution for the welfare of students and the University. The candidate should be a regular, full-time student at the University between the age of 17-24 years and should have no academic arrears in the year of contesting the election. The candidate should not have disciplinary enquiry or action taken or pending against her/him.

**7. Officers of the Election.**

Chief Election Officer duly nominated by the Vice-Chancellor will have the overall responsibility of the elections of the Student Council.

### 9. Rules and Regulations for Elections.

- a. The term of the office of the elected Student Council shall be the academic year 2021-22.
- b. The election will be done by an online voting system.
- c. The elections would be conducted by Student Welfare with the overall responsibility of the Chief Election Officer.
- d. The nomination form must be obtained and submitted to the Office of Student Welfare.
- e. Applicants may only utilize hand-made posters and that too at certain places in the campus as specified/notified in advance by Chief Election Officer and Dean Student Welfare.
- f. The use of loudspeakers, vehicles etc is completely prohibited.
- g. No criticism shall be accepted from one applicant towards another on the aspects of private life or aspects not connected with what is required for contestation.
- h. The sentiments (as based on caste, religion, economic status etc.) of others to be secured at all cost by the applicants and shall in no case be used for election purposes.
- i. The meetings held or any activity of applicants shall not disturb the conduction of classes, academic or co-curricular activities of the University.
- j. No group canvassing is permitted in the University campus.
- k. Voting rights will be given only to the students enrolled full time in the University.
- l. No damage to any property would be acceptable.
- m. Self-attested copies of marks sheets issued by the University for the previous years for which the candidate has appeared must be attached with the nomination form (Appendix I)
- n. The applicant shall be expected to submit undertakings (regarding academic arrears, disciplinary enquiry, not being detained in examinations and shortage of attendance) along with the nomination form (Appendix I).
- o. Incomplete nomination forms will be rejected.
- p. The withdrawal of the submitted application shall only be done via Student Welfare.
- q. If an elected candidate is found unsuitable/ineligible on any grounds after holding the post, the candidate will cease to be the elected candidate for the purpose of the Students Council immediately after the ineligibility is identified.
