- d. To enhance understanding within and between groups through interaction and communication.
- e. To increase avenues of cooperation among the administration, faculty and students.
- f. To promote respect for law and order and general welfare of the University and the community.
- g. To assist in organizing and developing different activities within the University and ensuring participation in other universities.

As per notified schedule from the office of Dean Student Welfare, applications for nominations will be invited and accepted from candidates of all Schools on the basis of their performance in curricular and co-curricular activities, achievements & accomplishments, leadership and managerial qualities, discipline and conduct in the preceding years at the University or in their previous institutions, the potential for contribution for the welfare of students and the University. The candidate should be a bonafide student of the University and should have no academic arrears in the year of applying for nomination. The candidates should not have disciplinary enquiry or action taken or pending against them. The most appropriate eligible candidates among the nominations received for each post (office bearer) will be shortlisted and notified for an interview and interaction with a panel. Subsequently, constituted Student Council will be notified.

#### 9. Rules and Regulations.

- a. The term of the office of the elected Student Council shall be one academic year, i.e 2022-23.
- b. The nomination form must be obtained and submitted to the Office of the Dean Student Welfare.
- c. Self-attested copies of marks sheets issued by the University for the previous years for which the candidate has appeared must be attached with the nomination form (Appendix I).
- d. The applicant shall be expected to submit undertakings (regarding academic arrears, disciplinary enquiry, not being detained in examinations and shortage of attendance) along with the nomination form (Appendix I).
- e. Incomplete nomination forms will be rejected.
- f. The withdrawal of the submitted application shall only be done via the Office of Dean Student Welfare.
- g. If the designated candidate is found unsuitable/ineligible on any grounds after holding the post, the candidate will cease to be the designated candidate for the purpose of the Students Council immediately after the incligibility is identified.

- a. After the constitution of the Student Council, strikes, protests etc. are strictly discouraged. In case of any such activity is observed, it would immediately lead to the disbarment of the Office Bearer concerned or the dissolution of the Student Council.
- 10. Disqualification for Office Bearers of the Student Council.

No students shall be entitled to be a member of the Student Council if,

- a. He/she is not a student of K R Mangalam University, Gurugram, Haryana; or
- b. He/she has been detained from the examination for the shortage of attendance or any reason; or
- c. He/she has been found guilty of and punished for the use of unfair means in any of the examinations of the University.
- d. He/she has disciplinary action taken or is pending against him/her; or
- e. He/she has failed or has academic arrears/ supplementary pending in any subject of any semester/year, or
- f. He/she has been convicted of a criminal offence including moral turpitude; or
- g. He/she has been punished by the University/School/Department for an act which is coercive in nature and constitutes a threat to life and property.

Explanation: A mere warning issued against a student will not be deemed to be a Punishment for the purpose of this clause.

- d. The Secretary of the Student Council will act in consultation with the President and will function in all matters relating to the Student Council in accordance with this Constitution.

#### 14. Meetings.

- a. The Student Council will meet at least four times in an academic session.
- b. The President of the Student Council shall preside at the meetings of the Student Council and it shall be his/her duty to conduct these meetings in an orderly and peaceful manner in accordance with this Constitution.
- c. An agenda of the meeting will be issued along with the notice of the meeting except for an emergency meeting.
- d. The minutes of all the meetings of the Student Council should be properly maintained by the Student Council.
- e. Rulemaking and Amendment of the Student Council Constitution.
- f. The Patron may appoint a Committee for framing such rules as may be necessary for the working of the Constitution and for making amendments to the Student Council Constitution. The rules so framed and amendments made in the Student Union Constitution will come into effect from a date to be notified by the Patron.




