
Key Deliberations

The meeting for the planning of the Workshop on Forensic Concepts was held on 11th May 2023 at 2:30 PM in Room No. 305, Block B. The meeting was convened by Dr. Neeraj Kumari and attended by faculty members Dr. Nidhi Gaur, Dr. Sonu Mehla and Dr. Rupali, along with student representative Mr. Piyush Sharma, Mr. Abhay, Mr. Agnivesh, Mr. Amrit, Ms. Jitika from B.Sc. programme. The agenda was to discuss the organization of a one-day hands-on workshop aimed at introducing students to fundamental forensic science tools and techniques, with a focus on practical application in the field of crime investigation.


It was decided that the workshop would cover essential topics including fingerprint lifting and analysis, blood spatter patterns, and an overview of chemical techniques used in forensic toxicology. Dr. Sonu Mehla agreed to lead the session on fingerprint and trace evidence analysis, while Dr. Rupali would handle demonstrations related to forensic chemistry. Dr. Nidhi would oversee the coordination and moderation of sessions. Ms. Jitika was assigned responsibilities such as managing registrations, coordinating logistics, distributing workshop material, and collecting feedback from participants.
