Introduction

On 07.04.2022, Legal Aid Committee & Health Society in collaboration with DLSA and Medox Hospital has organized a Legal Aid & Health Camp at Ghamroj Village. With the thought that the constitutional pledge is fulfilled in its letters and equal justice is made available to poor, downtrodden and weaker sections of the society and along with this health should be given equal priority.

Objectives

- To spread awareness about welfare legislations and schemes.
- Strengthen the community's access to the schemes being implemented by the Legal Services Authority and other departments of government.
- Identifying and connecting people to welfare schemes to ensure that fruits of welfare schemes are passed to eligible people.
- To understand legal and health needs of people and address the concerned problems of people by giving appropriate advice and taking other necessary steps.

Content

K.R. Mangalam University The main aim of this camp was to provide free legal and medical services to the needy people of Chamroi who are not abla to affine the services to the needy people. of Ghamroj who are not able to afford these services.

Around 25 students had volunteered in the legal aid camp and were further divided in to various groups. We visited the people who reside in that locality to enquire and know about their problems. We wrote down our inferences to discuss the issues. We assured them of legal assistance along with that and asked them to pay a visit in nearby Dharmashala in case they were facing any medical issues since a free medical aid camp was already set up over there.

People were courteous and welcoming in nature. We had listened to a lady who told us that she and many others had a case going on against the municipal corporation. She further told us that the land on which they are living for long the government has now claimed it to be under their authority and alleged that we had illegally occupied it. As per the aggrieved the government wants them to vacate their home and land. Likewise many others had shared their problems such as not having well maintained roads, sanitations problem, etc.

The volunteers of the legal aid committee did door to door activities while other side of the Dharmashala the Health Society of K.R Mangalam University in collaboration with Medox Hospital had set free medical aid camp. The camp had various doctors and health experts along with some students to provide medical help to those in need who cannot afford the hefty bills of the hospital but required assistance. They were given basic medical assistance, dental hygiene check ups, blood pressure and diabetes testing etc. many other issues were resolved by the team and they guided the villagers on first aid.

Attendees:


25 students of K.R Mangalam University and 27 villagers from Ghamroj Village participated in this camp.




