#### Introduction


8<sup>th</sup> March, which is widely celebrated as the "International Women's Day", commemorates the social, political and economic achievements of women.

The major idea behind celebrating "Women's Day" is to empower & encourage women, by making them aware of their legal and financial rights. The basic aim is to create a gender-neutral world we live around. With this idea, to celebrate this occasion, our university organised a Legal and Financial Awareness Camp in Village Siraska, Sohna, Gurugram, Haryana.

#### Objectives

- To spread legal literacy amongst the citizens of India, especially, the weak, down-trodden and poor, irrespective of race, caste, sex, colour or creed;
- To take up public causes in public interest and find remedies in accordance with law for the protection of the environment and to improve the surrounding living conditions of the citizens of India with greater stress on the economically weaker sections of the society, etc.
- To arrange talks, lectures, speeches by eminent personalities in the field of law, public affairs, social services, etc., to promote the aforementioned objectives;

- To arrange legal aid camps to settle disputes amicably amongst the citizens of India and to set up alternative methods of redress of grievances, especially, by voluntary consent of the adversary parties;
- To establish, run and promote centres for the training of young advocates with a view to indicate the spirit of service to the society and with the objective of producing dedicated lawyers who in turn could serve the society professionally in the years to come;

## Content

The event commenced with the empowering speech delivered by one of our university's student Mr. Deepak Dwarka. From paying due regards to the villagers who helped us in organising this whole event to recognizing the achievements of few incredible women in various fields, like the valiant freedom fighter Maharani Laxmi Bai, Olympic gold medallists Babita and Geeta Phogat etc, the introductory speech was an inspiring one.

Then, a **Nukkad-natak** was organised by university's team. Main theme of this Nukkad-Natak was "**Apne Adhikar Jane – Know Your Rights - Women**". (Picture – 7 & 9) The team started with so much zeal and excitement that gathered the attention of huge crowd especially women.

The main reason for choosing "**International Women's Day**" was the fact that there are various rights that are available to women by virtue of law of the land i.e., Constitution of India as well as other specific legislations. But, due to lack of awareness of all those rights, more often women fail to avail benefit of the same by not being able to exercise those rights.

Some basic rights that were showcased and highlighted in the nukkad-natak are as under: -

1. **Section 46 of the Code of Civil Procedure, 1908**
2. **Rights at Workplace:**
3. **Rakharakhaav/ Palan Poshan/ Maintenance Rights**
4. **Rights in Property**

The completion of nukkad-natak was followed with address by Dr. Rashmi Singel, Associate Professor, School of Management and Commerce and Mr. Dharmveer Yadav, Assistant Professor School of Legal Studies. Dr. Rasmi discussed about the importance of financial savings and how financial awareness will lead to economic and social empowerment of women. Women were made aware about the various government schemes like Pradhan Mantri Jan Dhan Yojna, Pradhan Mantri Jeevan Jyotia Bima Yojna, Pradhan Mantri Suraksha Bima Yojna, Atal pension yojna and PM Jan Arogya Yojna. Women are encouraged to get their saving bank account opened with local bank and get the benefit under these schemes. Mr. Dharmveer highlighted various legal rights of women and specifies the women participation in the country. The locality also been informed about the Legal Aid Centre, KRMU and advised if they face any legal issues and need assistance, can visit.

At the end of camp, Sarpanch of **Siraska** village, **Shri Ompal** expressed his sincere gratitude to the whole team for conducting this camp and thereby spreading awareness amongst women

This line of events was followed by the door to door service provided by us for distributing our university pamphlets so that they could reach us in case anyone wanted to seek any legal help wherein we could provide them with all the help they need, and could also help them to get in touch with District Legal Services Authority which pertains to provide free legal aid to the needy ones.

After interacting with women of the village we got to know that they were happy with our show and the initiative undertaken. They were glad that we conducted such an awareness camp for them.

There we bid adieu to the warm and kind hearted crowd who so lovingly accepted us all and allowed us to show them all that we had prepared. Thereafter, we headed back to our University.

### **Attendees**



### **Conclusion**

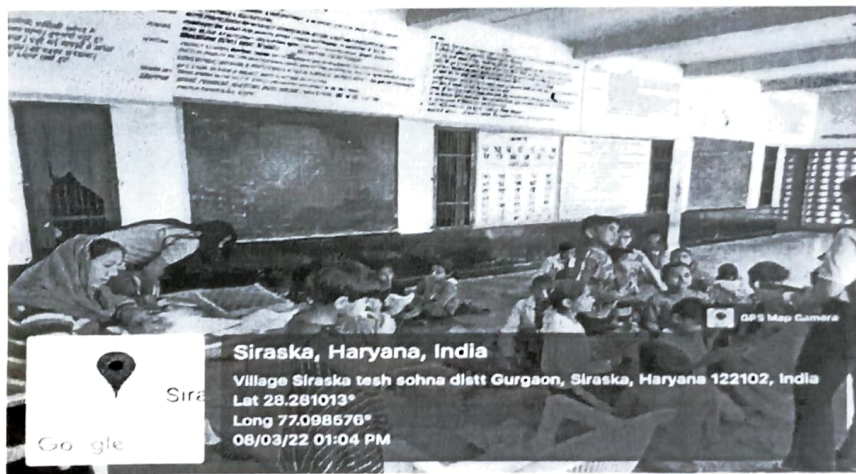

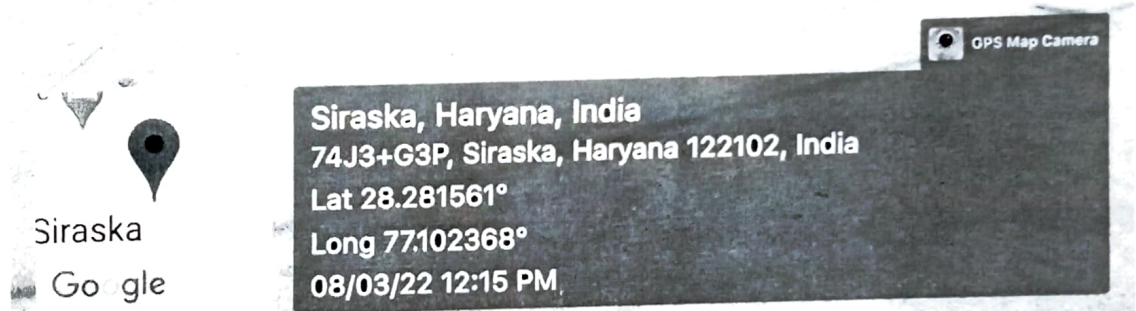



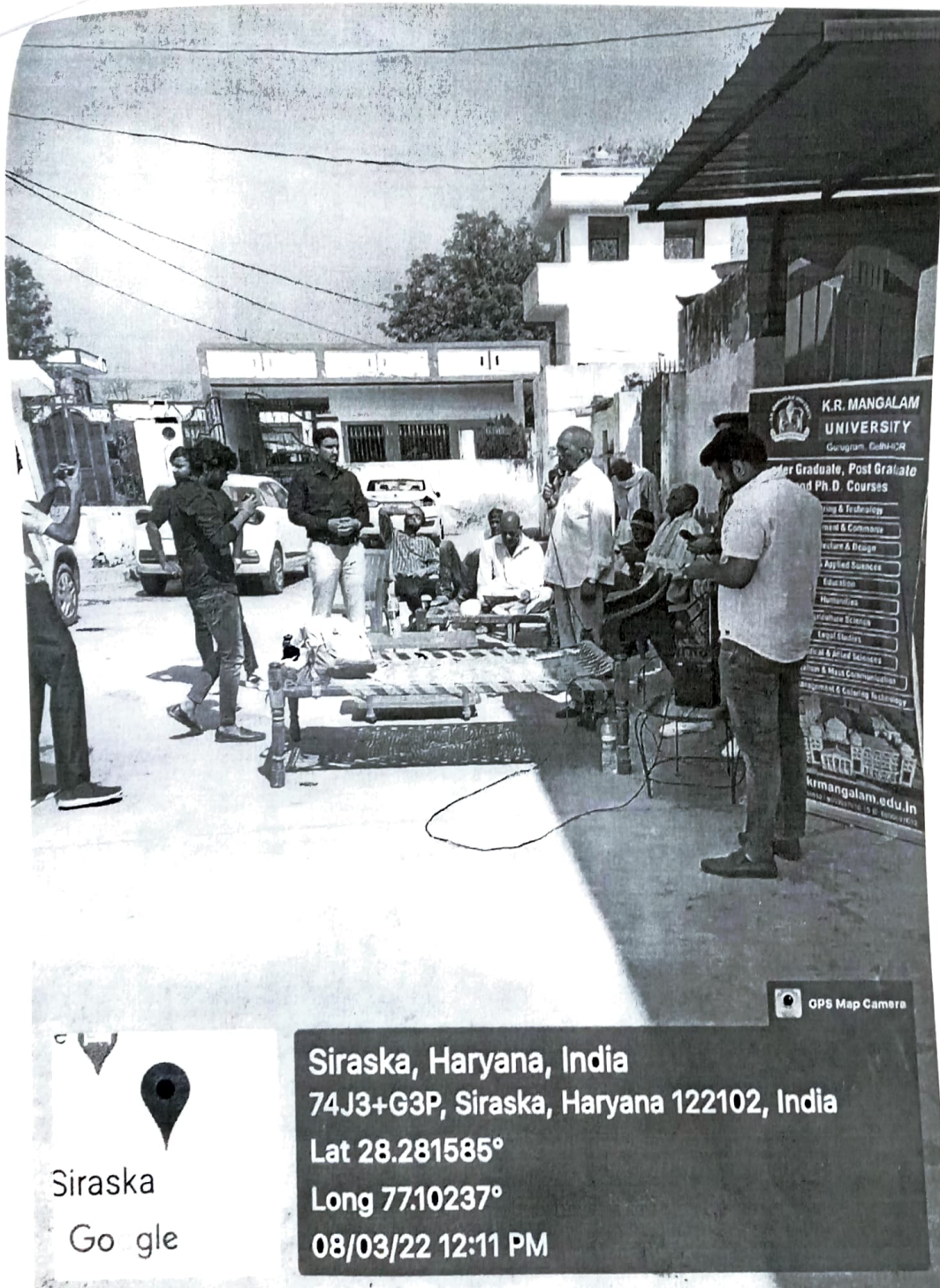


Picture 7 The Performance of the Nukkad Natak on the theme "Apne Adhikar Jane - Know Your Rights - Women"

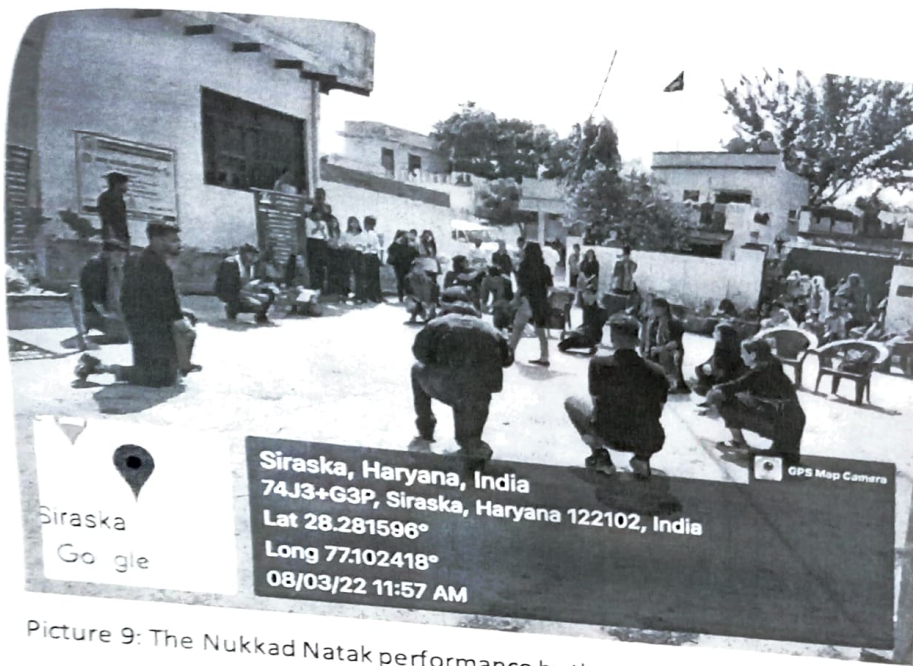
