Objectives

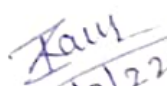
To make the students acquainted with the competition exams.

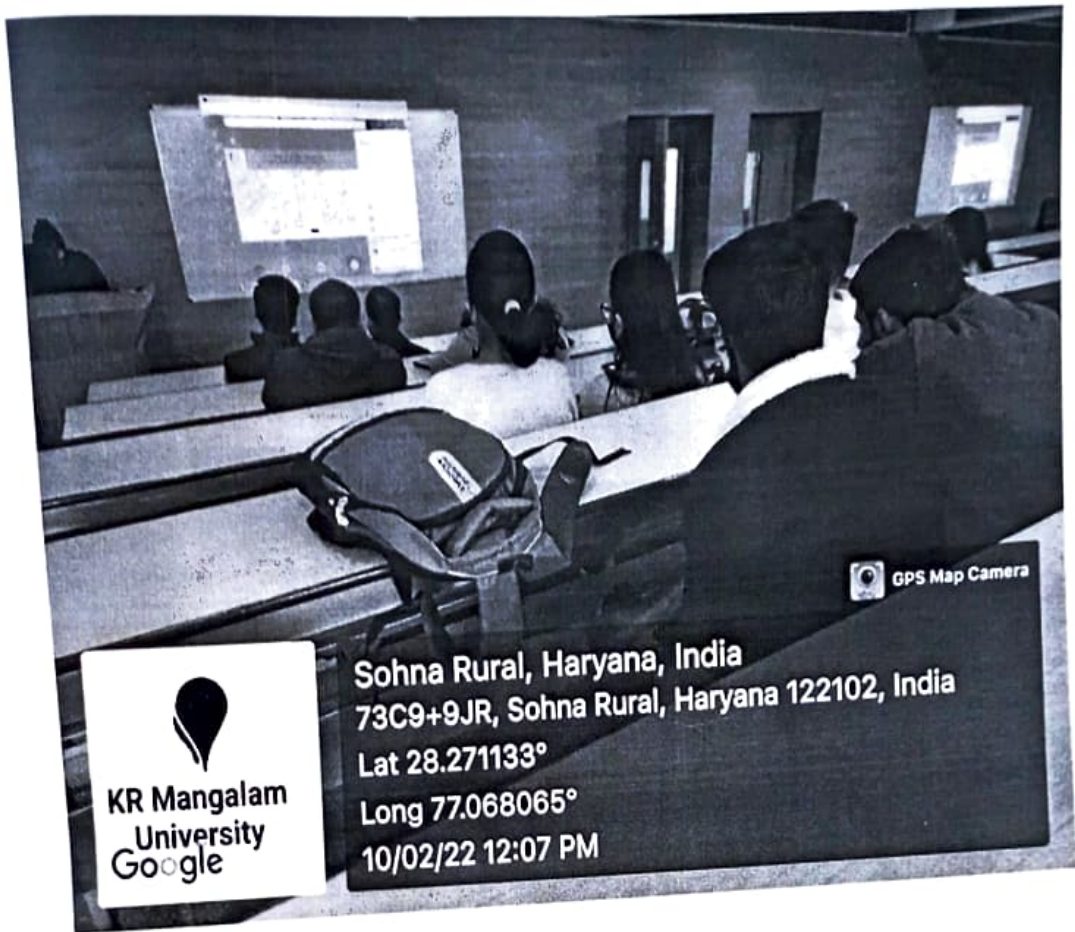

Workshop on “Crime and Punishment: The Law of Rape in India and “Confession to Police Officer”

Target Group: Students of School of Legal Studies

Date and Time: Monday, 9th May, 2022, 11 A.M

Venue: Room No.213, A Block, KRMU. It was an offline workshop.

Introduction

With the aim to guide students on the development of law a workshop was conducted by Dr. Nikhil Kashyap and Mr Uday Singh Rathore from Karat Law Academy. The main objective was to highlight the intricacies of important legal aspects to the students.

Objective

The main objective was to decode these questions and to come with a conclusive solution.

- What is Rape? Is the current punishment for rape sufficient?
- Should there be Death Penalty?
- Should Marital Rape be criminalised?

Content

The workshop was commenced by Dr. Nikhil Kashyap, who posed questions as to why there should be death penalty in the case of rape, and if that happens would the crime stop immediately? To which he gave very compelling answers. He explained the term rape and that its essentials are twofold-

1. Penetration (actus reus)
2. Without consent or will or under the age of 18 years

He also explained the difference between will and consent with strong examples. Further, he discussed whether marital rape should be criminalised or not. Plus, the point of views of the religious sects. Major Amendments were mentioned of the Criminal Law Amendment Act, 1983 wherein, he mentioned the cases: Mathura Rape case, Kathua Rape Case 2018, Unnao Rape Case and Nirbhaya Rape Case.. In short, this session covered the aspects of law regarding rape and the question whether marital rape should be criminalised or not.

The next session was conducted by Mr Uday Singh Rathore. He taught everyone the most important topic of CrPC, that is, "Confession to Police Officer". Several judgements by Supreme Court were referred in order to make the concept clearer.

Attendees

Students and Faculty of School of Legal Studies attended the workshop.

Outcome

The students got to learn about these issues in more depth and the importance of such laws which will make or break the country.

Conclusion

This workshop was an overall success as it gave an insight into the rape laws and covered basic topics under CrPC & IPC.

Further Scope

Organizing such an event will give students a deep insight into the current developments in various laws.

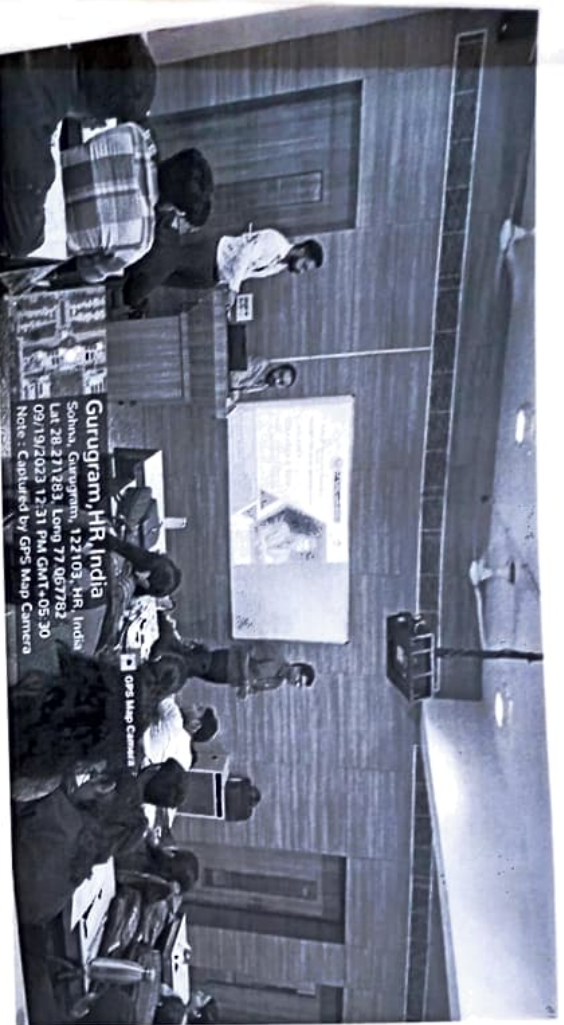
