

MEMORANDUM OF UNDERSTANDING

Between

K.R. MANGALAM UNIVERSITY

AND

PAHUJA LAW ACADEMY

I. Parties

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into by and between the K.R. Mangalam University, Sohna Road, Gurugram (herein after referred as KRMU), and Pahuja Law Academy (herein after referred as PLA)

II. Purpose

The purpose of this MOU is to establish the terms and conditions under which the academic collaboration between the parties can be effectively executed.

III. Term of MOU.

This Agreement shall be effective as on the date of signing of this Agreement (the "Effective Date") and will be in force till expiry of one year from the date of effective date.

IV. Tenure & Termination

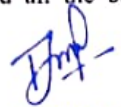
- (a) The duration of the present agreement is for one year and will remain in force for the said period subject to adherence with the terms and conditions of this Agreement. On expiry of the Agreement, the same may be renewed for a further period as determined by mutual consent of both parties.
- (b) Either party (a "terminating party") may terminate this agreement by notice in writing to the other party (the "other party") effective 30 (THIRTY) days.
- (c) In the event either party defaults or breaches any of the provisions of this agreement and fails to remedy the default or breach within a period of 30 (thirty) days after having been informed of such default or breach by the other party by registered letter or e-mail, then the other party shall have the right to terminate this agreement without notice.
- (d) Apart from above, Agreement can be terminated by Mutual consent of the Parties.

V. Amendment to the Agreement

If during the operation of the Agreement, such circumstances arise which require any alterations or modifications of the Agreement, then such required modifications/ alterations will first be mutually discussed and subsequently endorsed in the form of an appendix to the Agreement.

VI. Academic Collaboration between the parties

- (a) Minimum two Academic Lectures per month by the experts from PLA for the 2nd, 3rd, 4th and 5th year students of BBA .LP(H)/ BCOM LLB(H)/ BA LLB(H) and all the batches of LLB(H).of K.R Mangalam University.

- (b) KRMU students shall be given discount at PLA for Common Law Admission Test (LLM) or Judicial Services Examination. The discount shall be Rs.20,000/-.
- (c) KRMU can interact with the CLAT aspirants @ PLA and the data of such students shall be shared with KRMU by PLA. KRMU shall organise webinars by legal experts from Industry & Academia which the students of PLA shall join.

VII. Rights & Responsibilities of the parties

- (a) PLA shall maintain confidentiality regarding all tangible / intangible information provided by KRMU and the data and records maintained by it related to the admission process.
- (b) No financial assistance, in whatsoever manner, shall be provided by either party for any kind of collaborative activities.
- (c) PLA shall not use, in any form, the logo of KRMU or any information related to KRMU unless approved by the latter.

VIII. Events and Conference Sponsorship

- (a) Minimum three events, organised by the School of Legal Studies, KRMU shall be sponsored by PLA.
- (b) PLA shall be provided space for registration desk to distribute study material to the participants at the conference

IX. Miscellaneous

- (a) All formal communication (Letters / Requests / Notices) shall be made in writing and shall be deemed to be sufficiently given or made, upon being delivered personally or by AD registered post to the addresses set forth below, or at such other address as shall from time to time be notified to the other party:

The School of Legal Studies, K.R. Mangalam University organized an offline workshop on "The Indian Evidence Act, 1872" on 18th November 2021 from 2:00 PM to 4:00 PM. The Guest Lecture was organized in collaboration with the **Pahuja Law Academy**, which is known for the coachings for Judiciary. The lecture was attended by more than 60 students and 5 Faculty members of the department of School of Legal Studies.

The aim of the guest lecture was to equip students with the basic necessary knowledge in the subject of evidence in India, with all the necessary amendments. The guest speaker began the lecture with the important concepts of Substantive Law, Procedural Law and the Adjective Law, and mainly the difference between the three kinds of law.

The guest lecture was made very interactive, not only for the senior batches, but also for the junior batches, by discussing other important criminal acts, the Indian Penal Code of 1860 and the Criminal Procedure Code of 1973. After delivering the lecture, the speaker encouraged students to clear their doubts and clarified many doubts, not only which were related to the subjects but also related to the future judiciary examinations

It was a very informative and interactive session where students came to know about the career choices in the legal field, specially in Judiciary (Consulting). The lecture was received with admiration by the students and the faculties members. It was also a great initiative taken by the faculties of School of Legal Studies, in collaboration with the Pahuja Law Academy, for conducting this wonderful session of knowledge sharing and gaining, especially during this pandemic.
