Agenda 5.03: To report the progress of NAAC data compilation

The progress report of the data collected by each criterion head was shared in the meeting. It was suggested that a more conferences and faculty development programs should be organized by the schools to ensure that faculty is regularly upgraded.

Moreover, greater number of curricular, co-curricular and extracurricular activities should be organized by the schools for holistic development of students.

Agenda 5.05: To share the draft of the policies to be amended

It was proposed in the meeting that policies need to be reviewed and draft proposal of revision of policies should be put up in forth coming meetings.

Agenda 5.06: To propose revision of syllabus for academic year 2019-2020

It was suggested in the meeting that Choice Based Credit System (CBCS) needs to be implemented in all programs from 2019 onwards and students must be given greater choice of discipline specific electives, open electives and value-added courses. The methodology of teaching should be student centric by engaging them in projects, internships, case studies etc.
