Director IQAC, Prof. Kiran Bala welcomed the members of IQAC to the meeting. IQAC Chairman appreciated the efforts of faculty to collect the necessary documents for submission to NAAC. Director IQAC presented the agenda of the meeting before the members.

Agenda item No 7.01 To confirm the minutes of 6th IQAC Meeting

Minutes of the 6th meeting of IQAC were circulated and as no objections were obtained, minutes were confirmed (Annexure 1).

Agenda item No 7.02 To plan for collection and compilation of data by IQAC members for submission of SSR.

It was emphasized in the meeting that data will be collected, compiled by IQAC members and will be presented in the next meeting to give a holistic view of the university's performance. The gaps would be analyzed and a strategy to fill those gaps will be formulated.

Agenda item No 7.03 To apprise status report on PAN University Project on Covid-19

Director IQAC presented before the committee that during Covid, University conducted project on Covid 19. 961 students were registered for the project under the guidance of faculty and studied different aspects, from the origin and spread of Covid 19 along with the response of people and national leaders towards the pandemic.

The project revolved around the various nine themes as mentioned below:

Conversion of Community Spaces into Quarantine Zones
Covid-19 - Biological Weapon vs Legal Weapon
COVID-19 and Global Economic Recession
Health, Hygiene, and Immunity Boosters during COVID-19
Life Cycle of Covid-19 – Stages and Treatment
Narratives and Media on Pandemic: A Contextual Study on Covid-19
Nature of Epidemic - Past vs Present
Portrayal of Covid-19 as an epidemic/disaster
Starting Afresh: World after COVID-19

Meetings regarding the project were conducted under the chairmanship of Vice Chancellor in April and May 2020 and report has been submitted (Annexure II)

It was apprised in the meeting that university has adopted learning outcome-based curriculum framework and Program Outcome and course outcome of Program and course have been well defined by the schools and Program handbooks have been prepared accordingly. Courses on communication skills, computer skills, research skills, Indian knowledge system, stress management etc. have been introduced.
