

# **MEMORANDUM OF UNDERSTANDING**

This **MEMORANDUM OF UNDERSTANDING** (hereinafter referred to as "MoU") is made and entered into this 23rd February, 2023.

**BETWEEN**

Hawk Eye Forensic (hereinafter referred to as "SRMIST"), with a registered address at C- 38 Second Floor, Sector-65, Noida, Uttar Pradesh 201301 through its Managing Director, presently Mr. Ashish Kuntal duly authorized to enter into and sign an MOU on behalf of Hawk Eye Forensic.

**AND**


K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, presently Gp. Capt. P. Mahajan duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University

Hawk Eye Forensic and K.R. Mangalam University, are collectively referred to as "Parties" and or individually referred to as "Party."

**1. Purpose**

The Parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the further promotion and understanding of Forensic Sciences (hereafter, collectively referred to as the "Field").

The purpose of this MOU is to define the areas for fundamental, academic linkages in which the Parties desire to work together in the future for their mutual benefit to foster a collaborative framework between Hawk Eye Forensic and K.R. Mangalam University, Gurugram in the Field with a view to benefiting from each other's initiatives and working procedures and to support collaboration among the researchers associated with both Parties.



## **2. Scope**

This MOU sets forth the intentions of the Parties for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the Parties later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each Party's contributions, deliverables, and budgets.

## **3. Objectives**

1. Arranging industrial training for students and identify student project work, summer training, final year dissertation etc.
2. Utilizing the services of Hawk Eye Forensic professionals as visiting faculty or adjunct faculty for short or long period.
3. Deputation of University faculty to Hawk Eye Forensic to gain industrial experience and work on mutually agreed projects.
4. Associating experts from Hawk Eye Forensic in curriculum planning and reviews.
5. Guest lectures on mutually agreed terms by Hawk Eye Forensic Scientists /professionals.
6. Joint programmes in Research and Development including exchange of publications and reports.
7. Training programmes for students.
8. Delivering of Forensic Investigation Kits for professionals and students for betterment of students.
9. To provide Forensic instruments and tools.
10. International Global Certification courses in the field of Digital forensic and Cyber security provided by Hawk Eye Forensic and EC Council such as CHFI, CEH, CTIA, CND, certified Mobile Forensic and Computer Forensic.
11. To gain the experience in the field of Digital Forensic by the various license-based tools from Hawk Eye Forensic.

12. In-house and outhouse workshops and training for students.
13. Career guidance and career path advice for associated students for better scope of forensic in future.
14. To provide Special pricing quote for university association to use our services such as Internships, Workshops, Products, Special Training, International Certifications, Career guidance and many more.

#### **4. Finance**

Neither institution shall incur any financial obligations under this agreement. Applications for financial support towards the co-operation and individual activities planned under this agreement will be transparent and undertaken with mutual consent.

Other sources of finances raised to support these joint projects can be pursued with the knowledge of the other through intimation in writing.

#### **5. Responsibility for implementation**

Activities to be organized under this agreement will be the responsibility of the Heads of both institutions or of persons designated by them. National regulations and customs shall be mutually respected.

#### **6. Duration and Alteration of the Agreement**

The MOU will come into effect on the date of signature by both the parties and shall continue for a period of five years. On completion of five years, the MOU may be renewed for such periods and on such terms and conditions as may be mutually agreed upon by the parties to this MOU.

This Memorandum may be terminated by either party with two months' notice and/or may be terminated by either party, after the completion of any specific activity / activities in the process with mutual consent.

## **7. Confidentiality**

The parties agree that there is no intention to share any confidential or proprietary information in any collaboration under this MOU. If either party wishes to disclose information it considers to be confidential or proprietary to the other Party, the Parties will enter into a written non-disclosure agreement.

## **8. No Partnership, Association, Trust or Joint Venture**

Nothing under this MOU shall be deemed to neither constitute or create an association, trust, partnership or Joint Venture between the parties nor constitute any party the agent of any other party for any purpose.

## **9. Matters not provided in**


If any doubt arises as to the interpretation of the provisions of this MOU or as to matters not provided therein, parties to this MOU shall consult with each other for each instance and resolves such doubts in good faith.

## **10. Dispute Resolution**

In case any dispute of any kind whatsoever arises between the parties in connection with this MOU, will be resolved by mutual discussion.

That all disputes arising to this MOU shall be decided by the arbitrator which will be appointed by the mutual consent of parties. The proceedings shall be governed by The Arbitration and Conciliation Act, 1996 and Rules made there under or any enactment or statutory modification thereof in force for the time being. The decision of the arbitrator shall be final and binding on both the parties.

This MOU is executed in two counterparts each of which shall be deemed original but shall together constitute one document only.
