


Photo 1: Workshop on research writing facilitated by Mr. Prashant Panwar.




Photo 2: Mr. Prashant provided invaluable insights into the art of effective research writing.




Photo 1: Mr. Prashant providing comprehensive understanding of recent changes and developments in criminal law.




Photo 1: Mr. Prashant Elaborating the Importance and significance of Right to information.




Photo 2: Discussion on provisions of RTI Act 2005 by Mr. Prashant.
