MEMORANDUM OF UNDERSTANDING (MOU)

K. R Mangalam University, Sohna Road, Gurugram, Haryana-122103 (India) (hereinafter called KRMU which expression shall where the context so admits, include its successors and permitted assigns). K. R Mangalam University is established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956. The University is signing MOU through its **Registrar**, presently **Dr. Udayprakash Raghunath Singh** duly authorized to enter into and sign an MOU on behalf of **K.R. Mangalam University**, which expression shall, unless repugnant to the context or meaning thereof, be deemed to include its successors and assigns of the Second Part.

This MOU is to facilitate the process for offering academic and research activities by GV in collaboration with the selected University and Industry experts from Germany and Abroad.

K. R Mangalam University has expressed interest in partnering with GV to take up the GV offerings to all the School of studies at K. R Mangalam University.

NOW, THEREFORE, the Parties hereto, in consideration of the mutual covenants contained herein, agree as follows:

1. DEFINITIONS

- 1.1. In this MOU, except to the extent expressly provided otherwise:
- 1.2. "MOU" means this Memorandum of Understanding including any Exhibits, Annexures and any amendments to this MOU from time to time.
- 1.3. "Effective Date" means the date of execution of this MOU;

2. SCOPE OF MOU

- 2.1. International Placement Linked MS Programs
- 2.2. Short/Long Term Internships
- 2.3. Semester Exchange Programs to Germany/Europe
- 2.4. Apprenticeships
- 2.5. Project Exchange Programs
- 2.6. Dual Degree Programs
- 2.7. Credit based Certification - Virtual Programs
- 2.8. Industry Sponsored Job Linked MS programs
- 2.9. Faculty Exchange and Development programs

The Entire scope of MOU can be taken up in phases and this MOU will facilitate further discussion with German Varsity for specific progress regarding each scope of MOU.

3. WHEREAS:

- 3.1 "GV" having specialization in Certification Programs, Industry Sponsored Job Linked MS programs, Short/Long Term internships & other Career opportunities linked offerings.
- 3.2 **K. R Mangalam University** offers the bachelors, Masters and Research in all the School of studies at K. R Mangalam University.

4. TERMS OF AGREEMENT:

- 4.1 This MOU shall come into force upon the Effective Date.
- 4.2 This Memorandum of Understanding (MOU) will remain effective for **2 years from the date of signing.**
- 4.3 This MOU will be reviewed periodically between both the parties and their representatives to record the working and for further proceedings.

5. TERMINATION:

- 5.1. Either party may terminate this MOU by giving notice to the other Party not less than 180 days written notice of termination, expiring at the end of any calendar month OR after the end of the Minimum Term.
- 5.2. Either party may terminate this MOU immediately by giving written notice of termination to the other party if:
 - 5.2.1. The other party;
 - 5.2.2. Is dissolved;
 - 5.2.3. Ceases to conduct all (or substantially all) of its business;
 - 5.2.4. Is or becomes unable to pay its debts as they fall due;
 - 5.2.5. Is or becomes insolvent or is declared insolvent; or
 - 5.2.6. Convenes a meeting or makes or proposes to make any arrangement or composition with its creditors;
 - 5.2.7. An administrator, administrative receiver, liquidator, receiver, trustee, manager or similar is appointed over any of the assets of the other party;
 - 5.2.8. An order is made for the winding up of the other party, or the other party passes a resolution for its winding up (other than for the purpose of a solvent company reorganization where the resulting entity will assume all the obligations of the other party under this MOU); or

6. CONFIDENTIALITY:

Both the parties acknowledge that all material and information supplied by either of the party which has or will come into their possession or knowledge in connection with its performance hereunder, is to be considered confidential and proprietary information (the "Confidential Information") and shall not be disclosed to third party without prior written consent of any other party. However, the Confidential Information is being provided under this MOU "as is" and without any representation or warranty of any kind, either express or implied, regarding the accuracy or completeness or other quality of the confidential information. In no event shall either party or its affiliates or any of their respective directors, officers, employees, agents or representatives have any liability to other party relating to or arising out of any use of the Confidential Information in accordance with this Agreement.
