Memorandum of Understanding (MOU)

Mangalam University, Sohna Road, Gurgaon, Haryana - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its **Registrar**, presently **Dr. Udayprakash Raghunath Singh** is duly authorized to enter into and sign an MOU on behalf of **School of Management & Commerce, K.R. Mangalam University** (hereinafter referred to as hereinafter referred to as "Recipient") **PARTY OF THE SECOND PART.**

Purpose

The purpose of this Memorandum of Understanding (MOU) is to establish a collaboration between Provider and Recipient to deliver educational sessions on Artificial Intelligence (AI) to the students of Recipient.

Scope of Collaboration

- Provider agrees to deliver upto 3 on-campus (K.R. MANGALAM UNIVERSITY, Sohna Road, Gurugram, Haryana-122103) educational talks & Q&A of 60-90 minutes duration, on AI to the students of Recipient at no professional services cost.
- These sessions will be aimed at enhancing the understanding of AI concepts, applications, and implications among the students as per the agreed curriculum.
- Recipient agrees to facilitate the scheduling of these sessions and provide necessary logistical support, including venue arrangements and coordination with students.
- Both parties agree to collaborate closely to ensure the smooth delivery of the educational sessions.
- Recipient will designate a liaison officer to communicate with Provider regarding session scheduling, content requirements, and any other necessary arrangements.
- Provider will be able to use the Recipient's brand for promotion purpose.

Duration

- This MOU shall be effective from the date of signing and shall remain in force for a period of 12 months.
- Either party may terminate this MOU by providing written notice to the other party at least 30 days prior to the intended termination date.

Intellectual Property

- All intellectual property rights related to the educational content developed and delivered by Provider shall remain the property of Provider.
- Recipient agrees not to reproduce, distribute, or modify the educational content delivered by Provider without prior written consent.

Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this collaboration.

Dispute Resolution

In the event of any dispute arising under or in connection with this MOU, the parties shall endeavour to resolve such dispute amicably through negotiations. If the dispute cannot be resolved through negotiations, it shall be referred to arbitration in accordance with the laws of India.

Amendment


This MOU may be amended or modified by mutual written agreement of both parties. Any amendments shall be in writing and duly signed by authorized representatives of both parties.


