3. 师资合作培养。



无江西行政学院代表及 K.R. 曼格拉姆大学代表的书面签名文件，不得对本谅解备忘录进行任何修改和变动。



*WHEREAS*

K.R.Mangalam University, located in Gurugram, India, is a Haryana State Private university established in 2013; and

*WHEREAS*

Jiangxi Administration Institute, located in No. 1866 Longhushan Avenue, Honggutan New District, Nanchang City, Jiangxi Province, P.R. China, 330108, is an institute providing civil servant training and theoretical research.

*WHEREAS*

Both sides recognize that collaborative efforts will be of mutual benefit and may contribute to an enduring institutional linkage for educational co-operation and assistance,

*NOW, THEREFORE*

The Parties agree to continue discussions as opportunities arise to ascertain how co-operative activities could be implemented in the future. These activities include:

1. Open joint research in specific areas of mutual interest.
2. Open a variety of academic exchanges programs, such as leaders and scholars exchange visits, academic forum.
3. Train faculty members cooperatively.

Should specific joint activities arise as a result of further discussions, details will be set forth in an Agreement, to be signed at the appropriate time by the authorized representatives of the Parties.

This Memorandum of Understanding may not be modified, amended or otherwise varied except in writing and signed by the Representative of K.R. Mangalam University and the Representative of Jiangxi Administration Institute.

This Memorandum of Understanding will commence on the date shown below and operate for a period of five years.
