## **MEMORANDUM OF UNDERSTANDING**

The Memorandum of Understanding is executed on 1<sup>st</sup> August, 2022.

### **BETWEEN**

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amendment Act 08 of 2013) empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE FIRST PART.**

### **AND**

Indian Pharmacy Graduates' Association established in the Year 1973. The Association is registered as a society under the Societies Registration Act, 1860 having the office **F-2, A-block DDA shopping complex, Meera Bagh, New Delhi-110087**

The expression KRMU and IPGA, mean and include the Institutions/Organizations, their successors, appointees, assignees etc.

### **1. SCOPE OF THIS AGREEMENT**

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following:

- (i) Academic and Research collaboration in the areas of mutual interest. It is expected that this collaboration will in due course lead to collaborative research projects, joint publications, joint workshops, Joint Conference.
- (ii) IPGASF Collaborative project awareness campaigning & social outreach programme, Scholarly information, materials and publications.
- (iii) To create awareness amongst the pharmacy students, about the unlimited opportunities that they are capable of generating/ spreading in the health sector.

### **2. SEMINAR / CONFERENCE/ WORKSHOP/ CEP**

Students from KRMU will collaborate in the joint research and areas of mutual interest relating to Conference / Seminar/ / Workshop/ Continuing education programme.

All such joint activities will be governed by the following terms:

- i. Each institution will nominate one of its members as its representative in charge of the cooperative programme. Individual programme of work under this memorandum will be jointly planned and conducted by the nominees of both parties
- ii. Progress of work of any individual programme will be reviewed and approved by designated authorities of both parties.
- iii. Neither K.R. Mangalam University nor IPGA will be held responsible for any liability of the other party, and neither party shall be required to purchase any insurance against loss or damage to any property due to activities to which this agreement relates.

### **3. STUDENTS TRAINING**

- i. Students will be permitted to take participate in research Conference/ seminar / internships / project work & Work shop. with the consent of the teacher / project supervisors / research supervisors is required.
- ii. Participants will be subjected to the rules and regulations of the host institution.
- iii. The scope and duration of the collaboration may be amended and/or extended through the joint agreement with the consent and approval of both the parties.

### **4. COMMENCEMENT, RENEWAL, TERMINATION AND AMENDMENT**

This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three (3) years. This MoU may be renewed

upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of three years, it must notify the other institution not less than six months prior to the expiry of the MoU.

This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
