## MEMORANDUM OF UNDERSTANDING

This Agreement is being made between K R Mangalam University, Gurugram (that's "We" or "Our") located at Sohna Road, Gurugram, Haryana 122103, and Council for Social Development (that's "You" or "Your") located at Sangha Rachna, 53, Lodi Estate, New Delhi – 110003 on 18<sup>th</sup> January, 2024. You and We may also be referred to as "Party" or together as the "Parties". This Agreement will become effective on **24<sup>th</sup> January, 2024**.

### **BETWEEN**

**K.R. Mangalam University**, Sohna Road, Gurugram — 122103, Haryana, India (Delhi NCR Region), a state private university established under the Haryana Private Universities Act 2006 (Amended Act 08 of 2013), and empowered to award degrees as specified by UGC under section 2f of the UGC Act, 1956, through its Registrar, presently **Dr. Udayprakash Raghunath Singh**, duly authorised to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as '**KRMU**'), **PARTY OF THE FIRST PART.**

### **AND**


**The Council for Social Development (CSD)** was established in 1962 under the leadership of Dr. C.D. Deshmukh, former Finance Minister of Government of India, and Dr. Durgabai Deshmukh. Through research, advocacy and training activities, the organisation has tried to contribute to the formulation of policies and designing of programmes and build capacity in the areas of social development, particularly education, health, rural development and human rights (to the socially disadvantaged groups — dalits, adivasis, minorities, women, children, poor farmers and workers in the unorganised sector). CSD is one of the several institutions to integrate the dimensions of social development into the planning process for India's development; and is competent to sign this MOU through its authorised representative **Dr. Nitya Nanda**, Director on the behalf of Council for Social Development [hereinafter referred to as '**Council for Social Development (CSD)**'] **PARTY OF THE SECOND PART.**

The Expressions "KRMU" and "CSD" shall mean and include their respective successions, legal representations and assignees.

### **SCOPE OF MOU**

The parties will build collaboration on academic, research, training and Internship in the following categories:

- i. Both parties will collaborate for knowledge development programmes, training & certification in workshop, training, research work, field projects and student internships, and so on. Both parties herein agree as follows:

- Students' exposure to a research setting and faculty members' expanded understanding of research through lectures and workshops led by CSD Research Fellows
- Joint research publication endeavours between the two entities
- Collaboration on fruitful research initiatives including roundtables, conferences, and panel discussions, to which our and your subject-matter experts will be able to contribute.

And therefore,


- Conducting Expert Sessions, Seminars, Webinars, Workshop, Meet-ups.
  - Internship and training facilities.
  - Social Science and development-oriented training programs.
  - Collaborative research and projects.
  - On the Job-Training
  - Each institution agrees to use the other's name or logo in publicity related material with prior written consent from the other. The Intellectual Property policies in place at each institution shall apply to the activities initiated and implemented by the respective researchers. The Intellectual Property rights that arise as a result of any collaborative research, publication or activity under this Memorandum of Understanding will be worked out on a case-by-case basis, and will be consistent with the official Intellectual Property policies of the two institutions.
- Any other activities which may be agreed between the parties from time to time in writing.
  - Procedures followed in any activity under MOU will be reviewed and approved by designated authorities of both parties.
  - The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties in writing.

### **PAYMENT TERMS**

Council for Social Development, New Delhi shall be entitled to receive remuneration (financial support) for some of the above mentioned collaborations with KRMU from KRMU. The quantum of support, terms of support and the scope of work will be mutually decided on assignment-to-assignment basis as mutually agreed by both the Parties in writing. The terms of payment will also be mutually agreed between both the Parties.

### **COMMENCEMENT, RENEWAL, TERMINATION AND AMENDMENT**

This MoU will come into force upon affixing of the signatures of the representatives of the Parties and will remain in effect for three years subject to the condition of renewal at the end of every three years. This MoU will be renewed after the third year, with the agreement of both the Parties. If either Party wishes to terminate the MoU, it must notify the other institution not less than two months prior to date of termination.
