



(iv) Guided Self Publishing India will provide training and internship opportunities for SJMC students, allowing them to apply their academic knowledge in a professional newspaper setting, subject to mutual agreement and availability. This practical experience will contribute to the students' understanding of journalism and mass communication.

2. COMMENCEMENT, RENEWAL, TERMINATION AND AMENDMENT

This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three years subject to the condition of renewal at the end of each year. This MoU will be renewed each year, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU, it must notify the other institution not less than two months prior to date of termination.

This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
