3. KRMU and Medowsgreen will engage in training programmes, internships, exchange programmes, research projects and publications with faculty and students.



7. This MoU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MoU at the end of six months, it must notify the other institution not less than one (1) month prior to the expiry of the MoU.
8. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.




