Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE FIRST PART.**

Both parties herein agree as follows:


1. KRMU and CSI will collaborate for knowledge development programmes and training.
2. KRMU and CSI will organize guest lectures, symposiums, seminars, conferences, and other types of professional development activities for students

3. KRMU and CSI will engage in training programmes, internships, exchange programmes, research projects and publications with faculty and students.
4. There will be no financial liability on the part of either party.
5. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
6. This MoU will come into force upon affixing the signatures of the representatives of the partner institutions and will remain in effect for one (1) year.
7. This MoU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MoU at the end of six months, it must notify the other institution not less than one (1) month prior to the expiry of the MoU.
8. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.


