MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 9th February, 2024 is being made by and between:

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956. University is signing MOU through its Registrar, presently **Dr. Udayprakash Raghunath Singh** duly authorized to enter into and sign an MOU on behalf of Center of Excellence for Sustainable Development Goals, K.R. Mangalam University. (hereinafter referred to as KRMU), **PARTY OF THE FIRST PART**.

And

Deep Connection Innovation Private Limited (that's "We" or "Our" or "DeeCon") located at J100, First Floor, Mayfield Garden, Block J, Sector 51, Gurgaon-122018 (hereinafter referred to as KRMU), **PARTY OF THE SECOND PART**.

You and We may also be referred to as "Party" or together as the "Parties".

WHEREAS, K.R. Mangalam University, Sohna Road Gurgaon- 122103 (Delhi NCR Region), a University established under Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of the UGC Act 1956 having expertise in the areas of imparting quality education offers a myriad of Undergraduate, Postgraduate and Doctoral Degree Programs across multiple disciplines having its office located at Sohna Road, Gurugram Haryana- 122103, through its Registrar, duly authorized to enter into and sign a MoU (hereinafter referred to as KRMU) of the Party of the First Part.

The DeeCon provide a platform to parents/ guardian/ patients ("**the Customers**") to help and build faith and continuity in the therapy process. The Company will be designing a program time to time to provide different form of therapies under its brand name of Deep Connection

NOW THEREFORE THE PARTIES HERETO AGREE AS UNDER:

1. SCOPE OF MOU

1.1 This MoU details the structure and processes to be undertaken as a result of a collaboration between DeeCon and K.R. Mangalam University, Gurgaon

1.2 DeeCon makes K R Mangalam University, Gurgaon as university partner with the aim of introducing internship for physiology students.

2. OBJECTIVES

Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

3. PROPOSED MODES OF POTENTIAL COLLABORATION

Both the parties may collaborate through one or more for the following objectives:

3.1 DeeCon will provide to institute:

- a) Support in placement and internships (both on campus and in office) for students
- c) Time to time engagement and enrichment of students and faculty via training programs
- e) Support R&D capabilities of students and researchers in academic institute

3.2 Institute will provide company in main and allied campuses:

- a) A slot in the placement drive enabling the company to provide students with opportunities
- b) Create academic focus groups to study viability of new ideas and incubation

3.3 Mutual Benefits: Mutual promotions in respective events and websites which is relevant for the KRMU and DeeCon.

4. DURATION & TERMINATION OF MOU

4.1 The duration of the MoU shall be for a period of One Year from the date of signing the MoU. However, if both parties agree then the period can be extended.

4.2 In case if any party wants to end the MoU, then any one of them can serve a month's notice to each partner. This Agreement shall be governed by and construed in accordance with the laws of the Republic of India. In case any dispute arises, then the arbitrator may be appointed if mutually agreed or the matter shall be referred to the Alternative Dispute Resolution Mechanism and, in such instance, the matter will be resolved in Gurgaon.

5. RECRUITMENTS:

5.1 OPENING RECRUITMENT -

Inviting participation for the recruitment drive. This is the pre-recruitment stage, where DeeCon recruitment is promoted and interested students are requested to register for the same. The next two steps test the skills of the applicants.

5.2 GROUP DISCUSSION -

Applicants are divided into groups, and each group is given a unique topic on which the group is required to discuss and express their opinion. This step essentially tests the communication and presentation skills of the applicants.

5.3 PERSONAL INTERVIEW - Shortlisted candidates from Step 2 are raised to the next level of initiation. Personal Interviews of the candidates are taken by DeeCon in order to understand their personality and ascertain whether they are eligible to work in the organization or not. Candidates are then selected based on their performance in the aforesaid steps.

5.4 INDUCTION - Selected candidates are then formally inducted into DeeCon. This step involves induction of selected candidates about various aspects of DeeCon. They are then assigned to different teams in which they would be working.

6. WAIVER

Any waiver of a term or stipulation by a Party must be in writing, and such waiver will not constitute a waiver or modification of any other or future term or stipulation.

7. SEVERABILITY

If any provision of this Agreement is determined to be invalid or unenforceable, it will be deemed to be modified to the minimum extent necessary to be valid and enforceable. If it cannot be so modified, it will be deleted, and the deletion will not affect the validity or enforceability of any other provision.

8. ENTIRE AGREEMENT

The Parties hereto confirm and acknowledge that this Agreement along with any annexures exhibits etc. hereunder shall constitute the entire agreement between the Parties in respect of
