

## MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 22<sup>nd</sup> day of April, 2024.

### BETWEEN

**K.R. Mangalam University**, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 is empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE FIRST PART.**

### AND

**Jodhpur Rugs**, Guda Vishnoiyan, Jodhpur, Rajasthan, India is a group of 550 weaving artisans from rural Rajasthan who aim work with rural artisans to give them regular work and save the traditional art form, through Mr. Hasam Ji Data (CEO) duly authorized in this regard to sign an MOU on behalf of Jodhpur Rugs (hereinafter referred to as Jodhpur Rugs) **PARTY OF THE SECOND PART.**

The expression KRMU and Jodhpur Rugs shall, mean and include the University/Organizations, their successors, appointees, assignees etc.

KRMU and Jodhpur Rugs are individually referred to as "Party" and jointly as "Parties".

**PREAMBLE:** The purpose of this Memorandum of Understanding (MOU) is to develop academic and educational cooperation, and mutual understanding between Jodhpur Rugs and K R Mangalam University (hereinafter referred to as KRMU), Haryana, represented by its duly authorized signatory, the Registrar.

The primary objective of the collaboration to promote interaction and academic partnerships between faculty and students of the two institutions through visits, guest lectures and internship programs, sharing of industrial resources through expert talks, visits, reviews, internships etc. The relationship also aims at enhancing the technological, social, and cultural relations of both regions. This document presents a general framework for the collaboration. It also includes some specifically identified areas of cooperation, which may be updated from time to time.

**NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES:**

- 1. AREAS OF COLLABORATION:** The following areas of cooperation have been identified under this MoU.
  - i. Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
  - ii. Jodhpur Rugs will give valuable inputs to KRMU in teaching/ training methodology so that the students fit into the industrial scenario meaningfully.
  - iii. The interaction between Industry and Community College Centre will give an insight into the latest developments /requirements of the industries; Jodhpur Rugs to permit the Faculty and Students of KRMU to visit its workshops and also involve in Craft Cluster Collaboration. Jodhpur Rugs will provide its Labs/ Workshops/ Industrial Sites for the hands-on training of the learners enrolled with KRMU.
  - iv. Jodhpur Rugs will train the students of KRMU on the emerging technologies to bridge the gap in skill and make them ready for industry.
  - v. Jodhpur Rugs will extend the necessary support to deliver guest lecturers to the students of KRMU on the technology trends and in house requirements.
  - vi. Jodhpur Rugs will actively engage to help the delivery of the training and placement of students of KRMU into internships.
  - vii. Jodhpur Rugs will provide certification to acknowledge and appreciate student's work.
- 2. COORDINATION:** The provisions of this MoU will be implemented through a team of coordinators (faculty and students) appointed by the authorized signatory from both parties.
- 3. SCOPE OF COOPERATION:** The areas of cooperation may be revised by mutual consent. However, specific programs may require separate agreements detailed out and documented as annexures to this MoU.

4. **NON-DISCRIMINATION:** Jodhpur Rugs and KRMU agree not to discriminate any person because of age, sex, national origin, race, ancestry, color, religious creed, disability or handicap, and sexual orientation. Neither institution shall impose criteria for the exchange of faculty, staff and students that would violate the principles of non-discrimination.
5. **CODE OF CONDUCT:** Visiting students and faculty will abide by the codes of conduct of the host Institution. The parties should ensure that the faculty and students are made aware of the rules, regulations and other administrative procedures prior to the application and approval.
6. **INTELLECTUAL PROPERTY:** The intellectual laws of the Nation will be respected and adhered to by both the parties. The two parties may jointly own the results or data generated during the collaborative projects; however, the host institution will govern the protection and commercialization of data or any intellectual property created during any of the aforementioned modes of cooperation.  
Non closure agreements may be encouraged between the parties to clearly state the necessary and reasonable care to be taken to protect data or information.
7. **FINANCING:** Under this MoU, it is understood and agreed that there is no financial obligation between the parties. Additional support, if any, will be governed by separate agreements that may be drawn up for specific activities.
8. **LEGAL STATUS:** This document is a statement of intent to foster genuine and mutually beneficial cooperation and is not legally binding on any of the parties. Any disputes shall be resolved through mutual discussion.

**VALIDITY AND TERMINATION:** This MoU is valid for an initial period of **two years** and becomes effective from the date it is signed by the partners. The partnership period may be extended by mutual consent.

This agreement may be terminated:

- a. on either party giving the other party 6 months' prior written notice.
- b. on written notice by one of the Parties if the other Party has committed a breach of this MoU.

However, specific commitments made prior to such intimation shall be honored by both the partners including ensuring that any student at that time participating in the Program is able to complete the term of the assignment and be assessed for it.




