MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 25th day of April, 2024.

Between

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 is empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of Gender Sensitization & Safety Committee, Centre of Excellence for Sustainable Development Goals and Legal Aid Clinic of School of Legal Studies, K.R. Mangalam University represented by Chairperson, Gender Sensitization committee K.R. Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE FIRST PART.**

And

NEK Mission Foundation, an initiative by alumni of the Faculty of Law, University of Delhi represented by Dinesh Chand Meena, Executive Director (hereinafter referred to as "the Foundation") **PARTY OF THE SECOND PART.**

NOW, THEREFORE, it is hereby agreed as follows:

1. **Purpose:**


The purpose of this MOU is to establish a collaborative framework between the KRMU and the Foundation for the implementation of Project Saksham 3.0, a legal aid and literacy project aimed at providing legal assistance and education to marginalized communities.


2. **Scope:**

WHEREAS, the KRMU is committed to promote gender equality, spread awareness regarding gender sensitization and promoting legal education and providing legal aid to the underprivileged sections of society; and

WHEREAS, the Foundation, comprising alumni of the Faculty of Law, University of Delhi, is dedicated to furthering the cause of legal literacy and access to justice through various activities; and

WHEREAS, both parties share a common goal of empowering individuals through legal awareness and assistance;

3. **Project Saksham 3.0:**

- a. The KRMU and the Foundation shall jointly undertake Project Saksham 3.0, which aims to provide legal aid services, conduct legal literacy programs, and organize awareness campaigns on legal rights and responsibilities.
- b. The project activities will include Mega Camps, legal workshops, seminars, legal aid clinics, lectures and distribution of informational materials.

4. **Roles and Responsibilities:**


- a. The KRMU shall provide academic guidance, logistical and academic support, and access to resources for the successful implementation of Project Saksham 3.0 i. e. in the various academic and non- academic activities to be conducted under the SAKSHAM 3.0 ambit, such as conducting National Seminars, Workshops, Lectures, Speed mentoring sessions, educational visits in various Jaipur schools and conducting social outreach programs like organizing Mega Camps, Village Visits and many other activities under this ambit.
- b. The Foundation shall oversee the planning, execution, and monitoring of project activities, including volunteer coordination, outreach programs, and stakeholder engagement. The Foundation will provide opportunity to the Department students to work with the students of other prominent departments of all over the country.
- c. Both the parties in collaboration shall conduct various sensitization programs, training sessions for the volunteers, Jail visits, Lok Adalat visits and will prepare the final report SAKSHAM 3.0 project report.


5. **Resource Sharing:**

- a. The KRMU and the Foundation shall share relevant expertise, research findings, and best practices to enhance the effectiveness of Project Saksham 3.0.
- b. Any intellectual property developed jointly as part of the project shall be mutually owned and used for the advancement of legal education and advocacy.

6. **Funding:**

- a. The KRMU may allocate funds or seek external grants to support specific project activities, subject to availability and budgetary constraints.

- b. The Foundation may mobilize resources through fundraising events, sponsorships, or donations from alumni, organizations, or philanthropic entities to supplement the project budget.
- c. There will be an Inaugural ceremony and Valedictory ceremony of Project SAKSHAM 3.0 to be conducted tentatively in the month of April 2024 and December 2024 respectively. Both the parties shall collaboratively work for the successful organization of both the events and the KRMU will provide assistance like travel and food expenses of the KRMU' volunteers.

7. Duration:


