MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 26th day of April, 2024

BETWEEN

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a university established under the Haryana Private Universities Act 2006, and empowered to award degrees as specified by UGC under section 2f of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of School of Basic and Applied Sciences (Forensic Science) K.R. Mangalam University (hereinafter referred to as KRMU), **PARTY OF THE FIRST PART**.

AND

RJ Forsec Solution is an organization registered in India, with an office address at **RZF 777/14, Street No. 16, Raj Nagar 2, near Dwarka, Sector 8 Dwarka, Palam, New Delhi, Delhi 110077**, represented herein by its Director, **Mr. Jatin Saini**, (hereinafter referred to as "RJ Forsec"), **PARTY OF THE SECOND PART**.

1. SCOPE OF THIS AGREEMENT

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

i) Academic Collaboration:

- a) General Purpose is to establish an enduring framework for educational relations and cooperation between the two participating institutions in order to promote academic learning, training, research, and forensic consultancy works and to explore the possibility of joint academic and research ventures.
- b) Pursuant to the agreement for academic exchange, K.R. Mangalam University and RJ Forsec may invite faculty/experts to deliver guest lectures, organize FDPs etc.
- c) To conduct and organize seminars, and conferences to support the educational programs in the field of professional competencies (particularly the areas of Ethics, Professionalism in Forensic Science).
- d) To facilitate visits by students and staff to participate in internship programs, participation in research and completion of proposals and projects in the related field of Cyber and Digital Forensics, while understanding the regulations of the agreeing

institutions within the Areas of Cooperation. The expenses of the participating members from the visiting Institutions shall be decided mutually wherever feasible

(i) Research Collaboration

- a) Faculty from both Institutions will engage in joint guidance of research projects according to the terms mutually agreed by both parties. Participants will be subjected to the rules and regulations of the host institution.
- b) Proposals for collaborative research work under this Memorandum will be submitted with the prior approval of the Head of each institution, or his/her nominee.
- c) For research collaboration which shall involve writing collaborative research projects for funding and consultancy works. Research collaboration may be a part of the publication authorship group
- d) MoU will lead to the co-supervision of the project dissertation for under graduate students wherever required as per the provisions of KR Mangalam University.
- e) For any undergraduate research work, infrastructure and other facilities required for academic and research purposes will be shared.
- f) Each institution will nominate one of its members as its representative in charge of the cooperative programme. Individual programme of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
- g) Procedures followed in any activity under MOU will be reviewed and approved by designated authorities of both parties.
- h) Neither K.R. Mangalam University nor RJ Forsec will be held responsible for any liability to the party, and neither party shall be required to purchase any insurance against loss or damage to any property due to activities to which this agreement relates.
- i) Every collaboration will have its own agreement / contract which address issues such as IPR, funding pattern, usage policies of research facilities, disclosure of information etc.

2. COMMENCEMENT, RENEWAL, TERMINATION AND AMENDMENT

This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for one (1) year. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of one year, it must notify the other institution not less than two months prior to the expiry of the MoU.

The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both the parties.



