1. KRMU and CTPD India will collaborate for knowledge development programmes, training & certification in short-term courses and conducting joint inter-disciplinary research.



3. KRMU and CTPD India will exchange academic materials and publications.
4. There will be no financial liability on the part of either party.
5. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
6. This MoU will come into force upon affixing the signatures of the representatives of the partner institutions and will remain in effect for one (1) year.
7. This MoU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MoU at the end of one year, it must notify the other institution not less than two months before the expiry of the MoU.
8. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by exchanging letters between the two parties.


