ProLift Technologies Private Limited having registered address as C-111, Sector H, Aliganj, Lucknow - 226024 through **Mr. Harshit Malhotra, Co-Founder, and CTO, ProLift** which expression shall unless excluded by or repugnant in the context be deemed to include its successors and assigns. (hereinafter referred as "ProLift"), be the **PARTY OF THE SECOND PART.**

K.R. Mangalam University and **ProLift Technologies Private Limited** are hereinafter referred to individually as "Party" and collectively as "Parties"

The motive of this MoU is to outline the general terms and conditions of our proposed collaboration, subject to further negotiation and agreement on specific details. The purpose of this MoU is to establish a framework for cooperation between K.R. Mangalam University (henceforth called KRMU) and ProLift Technologies Private Limited (henceforth called ProLift).

1. SCOPE OF THIS AGREEMENT

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the academic and research collaboration is a key focus area of mutual interest. The parties will collaborate in skill-based training, internships, and other student-related events or programs as applicable.

2. SCOPE OF COLLABORATION

INTERNSHIP AND TRAINING OPPORTUNITIES AT PROLIFT:

- ProLift offers project-based internship opportunities to students from KRMU's School of Engineering and Technology (SOET) for a period of 1-3 months.
- ProLift will give research projects and technical assignments to the students in online/offline mode to be completed within a time period.
- ProLift will provide internship certificates to acknowledge and potentially enhance the students' resumes.
- The deserving candidates who perform the tasks given during the entire period will be offered a pre-placement offer (PPO) to join ProLift as a full-time working employee subject to the vacancy.

3. TERM AND TERMINATION:

This MoU shall come into effect upon the date of signing and will remain in force for an initial term of two (2) years, with the possibility of renewal by mutual consent. The MoU can be terminated by either party by giving a written notice of sixty (60) days by the party seeking termination to the other party. However, all commitments and obligations till the date of termination will be honored by both the parties.

4. FINANCIAL ARRANGEMENTS:

There will not be any financials included in this collaboration. This MoU is strictly for academic purposes.

5. CONFIDENTIALITY:

Both parties agree to treat information shared during the course of this collaboration as confidential and to take all necessary measures to protect sensitive data.

6. LIMITATION OF LIABILITY

Both parties agree that they are not liable to each other, or any other party not entering into this MoU, for any damages including special, incidental, indirect or consequential damages arising from any claims arising out of this MoU.

7. INDEMNIFICATION

The Parties each agree to indemnify and hold harmless the other Party, its respective affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from the negligence of or breach of this Agreement by the indemnifying party, its respective successors and assigns that occurs in connection with this Agreement. Any part of this MoU which is not enforceable due to any reason whatsoever will be deemed to be inoperative and the rest of the MoU will continue to be valid and binding on the Parties hereto.


