Akropolis Super-Speciality Hospital, Badshahpur, Gurugram, Haryana, 122101, India (hereinafter called Akropolis Super-Speciality Hospital, which expression shall where the context so admits, include its successors and permitted assigns) through its authorised signatory , presently Dr. Prateek Girotra - Director is duly authorized to enter and sign an MoU on behalf of **Akropolis Super-Speciality Hospital, PARTY OF THE SECOND PART.**


Whereas, the two parties recognize human resource development and institutional capacity building as the basis for a mutually beneficial cooperation program, hereinafter referred to as the Program.


Article I: Objectives of the Program

The objectives of the Program are to provide skill based learnings in various divisions of healthcare sector like pharmacy retail, diagnostics, hands-on trainings, collaborative research projects, publications, internships to students of **School of Medical and Allied Sciences, K.R. Mangalam University** and **Akropolis Super-Speciality Hospital** promote institutional linkage between **School of Medical and Allied Sciences, K. R. Mangalam University** and **Akropolis Super-Speciality Hospital** to explore other avenues for possible relationship where expertise exists and can be mentored by either or both of them.

Objectives:

To promote and enhance academic interest between **School of Medical and Allied Sciences, K. R. Mangalam University** and **Akropolis Super-Speciality Hospital**. To provide expert

talks on various issues related pharmacy education & health camp assistance between **School of Medical and Allied Sciences, K. R. Mangalam University** and **Akropolis Super-Speciality Hospital**.

To encourage bright students of **School of Medical and Allied Sciences** for providing hospital pharmacy related know-how at **Akropolis Super-Speciality Hospital** and vice versa.

- a) To provide internships to the students of School of Medical & Allied Sciences, K. R. Mangalam University.
- b) To promote research/continuing educational activities between both the institutions.
- c) To carry out joint collaborative medical and research activities.
- d) To plan and implement exchange of visiting experts for the purpose of conducting research.
- e) To carry out discussion for the exchange of facilities for collaborative research based on the policies of both entities.
- f) To exchange the scholarly information including research papers, indices to theses, books and magazines on relevant subjects and potential joint projects where possible and appropriate.
- g) To extend invitations for attending scholarly and technical meetings as well as national and international conferences.

Technical Areas of Collaboration

- a) A Continuing Quality Improvement Programme to improve quality of teaching at **School of Medical and Allied Sciences, K. R. Mangalam University** to students of **School of Medical and Allied Sciences, K. R. Mangalam University** for necessary hands on training and guidance via Workshops, Expert Talks, Student Internships, etc.
- b) Provide academic interaction by delivering special lectures at **School of Medical and Allied Sciences, K. R. Mangalam University** on topics of relevance to modern science and technology and vice versa.
- c) Provide necessary help in organizing workshops/conferences and Personality Development Programmes at **School of Medical and Allied Sciences, K. R. Mangalam University** for enhancement of skills among students of **School of Medical and Allied Sciences, K. R. Mangalam University** and vice versa.

Limitations of Authority:

- a) Neither party has authority for on behalf of the other except as provided in this MoU.

- b) This Agreement represents the entire Agreement by and between the parties and supersedes any previous letters, understanding or oral agreements between the **School of Medical and Allied Sciences, K. R. Mangalam University** and **Akropolis Super-Speciality Hospital**. Any representations, promises, or guarantees made but not stated in body of this Agreement are null and void and of no effect.
- c) Neither party may make, revise, alter or otherwise diverge from the terms, conditions or policies which are subject to this Agreement without a written amendment to this Agreement.
- d) Neither party may incur any debt, obligation, expense, or liability or any kind against the other without the other's express written approval.

ARTICLE II: SCOPE OF THE PROGRAM

School of Medical and Allied Sciences, K. R. Mangalam University and **Akropolis Super-Speciality Hospital** will jointly identify specific fields to conduct collaborative research programs of mutual interest in project mode involving a Scientist/Faculty from **School of Medical and Allied Sciences, K. R. Mangalam University** and assist in the conduction of internships to the students of **School of Medical and Allied Sciences, K. R. Mangalam University** and vice versa.

ARTICLE III: DURATION OF THE PROGRAM

This Memorandum shall enter into force on the date of its signing by both parties and shall take effect for a period of 3 (three) years.


AMENDMENTS/MODIFICATIONS


This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE IV: SPECIAL PROVISIONS

- a) Both parties hereto shall do their best efforts to ensure the smooth and efficient implementation of the Program.
- b) The **Dean, School of Medical and Allied Sciences K. R. Mangalam University** and **Director, Akropolis Super-Speciality Hospital**, shall meet periodically, at least once in a year to review the program and modify the scope, if required.
- c) All data generated under this Program shall be kept confidential.
- d) Nothing contained herein shall constitute this a partnership or joint venture agreement or constitute either party as the partner, principal or agent of the other, this being a

MoU between independent contracting entities.

- e) No amendment or modification of this MoU shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of this MOU. The modifications shall be effective from the date on which they are made.
- f) This MoU may be terminated at all times by either Party by giving written notice for 30 days. Either Party shall, upon termination of this MoU or upon request of other Party, whichever is earlier, return to such other Party all and any Confidential Information.
- g) In case of any disputes, the parties shall use their best efforts to settle all matters amicably between the **Dean, School of Medical and Allied Sciences K. R. Mangalam University** and **Director, Akropolis Super-Speciality Hospital**.
- h) Management of Program is as per the discussion and directions received from both parties from time to time.







