### Proposed Revenue Share

- The competent authority of K.R. Mangalam University, in consultation with ImaginXP, will determine the course fee, including tuition fee, development fee, and academic service fee, for each academic year for all degree programs.
- The revenue sharing agreement with Collegedekho will entitle them to 55% of the total fee collected per semester.
- It is agreed that this fee structure will apply only to the 2024 academic batch.
- Prices are inclusive of all taxes.

The above fees will be subject to revision at the beginning of each academic year through collaboration between both parties. The fee payment schedule for each new academic year will be appended as an addendum to this MoU."


"No other terms or conditions of the contract mentioned above shall be nullified or altered by this addendum."






