

3. KRMU and KIPBM will organize seminars, symposiums, and other types of professional development activities for faculty and students.
4. KRMU and KIPBM will exchange academic materials and publications.
5. There will be no financial liability on part of either party.
6. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
7. This MoU will come into force upon affixing of signatures of the representatives of the partner institutions and will remain in effect for three (3) years.
8. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of three years, it must notify the other institution not less than six months prior to the expiry of the MoU.
9. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.






