

(IACI)**, duly authorized to enter into and sign an MOU on behalf of IAC India Pvt. Ltd. (hereinafter referred to as IACI) **PARTY OF THE FIRST PART.**

WHEREAS, the parties herein wish to develop industry institute association for mutual benefit towards student, faculty and facility development

The Parties enter into this MoU on the terms and conditions set forth hereafter:





1. **COOPERATION:** Both Parties are to cooperate with each other to facilitate effective utilization of intellectual capabilities and market reach as promptly as is responsibly practical.

2. **SCOPE:**

a. K.R. Mangalam University may provide support to publicise **IAC India (P) Ltd** offerings and events within its student community, Social Media, University Informative Materials and faculty members.

b. Deliverables from IAC India (P) Ltd.:

1. Provide online training on Licensed Tally PRIME
2. Provide authorized E-Courseware from Tally
3. Enroll all students to the TEPL portal
4. Provide assessment and certification to the enrolled students
5. Facilitate Students with Workshops on IT-ITES advancements and Career Building.

c. Deliverables from TEPL for University and for all enrolled candidates:

1. Tally PRIME Multiuser License on an annual renewable basis on request
2. 2*2 Tally logo signboard to be affixed outside/ inside the computer lab
3. Online Assessment for the certification
4. Digital verifiable Certificate to students who pass the assessment
5. Access for students to the TEPL Candidate Portal
6. Mock assessments to students in the Candidate Portal to evaluate their progress

3. **CONFIDENTIALITY:** Either Parties have agreed to hold in confidence all shared information/data designated as "Confidential", without explicit consent. This excludes prior information available with either Party or available through public domain.
4. **INTELLECTUAL PROPERTY RIGHTS (IPR):** The IPR that may arise as a result of joint research or collaborative activities under the agreement will be worked out on a case-by-case basis and will be consistent with officially laid down IPR policies of the two organizations. However, in the absence of an explicit contract, this MOU does not imply or transfer rights to reverse engineer, use, own or licence intellectual properties of either parties.
5. **COMMERCIALS:**

6. There is no financial commitment on either Parties arising from this MOU. If there is any financial consideration, it will be explicitly dealt with on a case-to-case basis.
7. **Validity and Jurisdiction:** This Agreement shall commence upon the date of the final signature below and will be valid for one year until it is expressly terminated by either Party on mutually agreed terms. The MOU may be renewed by mutual agreement between the Parties.
8. This MOU shall not be legal binding on any of the Parties. However, in case of any dispute regarding the MOU, the parties will attempt to resolve the matter amicably. In the event of such an amicable settlement not forthcoming within 15 days of dispute the

parties shall submit their disputes to the arbitrator appointed by parties jointly with the venue as Gurugram.





