MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on August 13, 2022

BETWEEN

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 is empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as KRMU) PARTY OF THE FIRST PART.

AND

Smiling Tree Foundation, 19/1-C, Shakti Nagar, Delhi-110007 through Mr. Mukesh Kwatra duly authorized in this regard to sign an MOU on behalf of SMILING TREE, PARTY OF THE SECOND PART.

The expression KRMU and SMILING TREE shall, mean and include the Institutions/Organizations, their successors, appointees, assignees etc.

KRMU and SMILING TREE are individually referred to as "Party" and jointly as "Parties".

WHEREAS

SMILING TREE is a registered NGO primarily carrying out Plantation Drives, Environment Awareness Drives, Anti Plastic Drives etc. **SMILING TREE has a 12 A Registration vide no.ABBTS7749GE20217 and 80 G Certification vide no. ABBTS7749GF20223.**

AND WHEREAS Both parties have decided and agreed to work on mutually agreed terms mentioned in Articles below

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES:

AREAS OF COLLABORATION: That there will be collaboration between the KRMU and SMILING TREE in the areas of joint interests listed below:

- To carry out joint plantation drives in villages adopted by K.R. Mangalam University under CSR.
- To do periodic assessments of planted trees
- To carry out awareness programs related to environment
- To carry out Anti Plastic Drives
- To educate villagers regarding excessive use of pesticides and fertilizers.

- Monitoring of Villages and the plantation and environment there under CSR.

Commencement, renewal, termination and amendment

1. This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions. The tenure of this MOU is two years from the date of signing of the MOU. This MOU may be amended/extended for specified duration by mutual consent in writing of both the parties.
2. That this MOU may be terminated by either party at any time provided that the terminating institution gives to other party written notice of intention or termination to other party at least six months prior to termination.
3. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.


