The Expressions "KRMU" and "VYK" shall mean and include their respective successions, legal representations and assignees.

KRMU and VYK are collaborating for Academic Exchange & Cooperation in Education, Research and Training, Capacity Enhancement Activities, Community Outreach and Extension Activities, Projects in the areas of Education, Youth Empowerment, Health & Wellness, Women Empowerment, Gender Equality, Environment Conservation & Sustainability, Social Awareness and Entrepreneurship Development.

Both parties herein agree as follows:






3. KRMU and VYK will organize seminars, symposiums, and other types of professional and capacity development activities for faculty, students, youth and Civil Society Organizations (CSOs).
4. KRMU and VYK shall designate their representative for the smooth execution of the activities.
5. KRMU and VYK will exchange academic materials and publications.
6. There will be no financial liability on part of either party.
7. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
8. This MoU will come into force upon affixing of signatures of the representatives of the partner institutions and will remain in effect for one (1) year.
9. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of one year, it must notify the other institution not less than three months prior to the expiry of the MoU.
10. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
