And have hereby decided that both parties would adhere to the following responsibility charter of listed below:

**Section-1.0: MOU Signatories:**

The signatories of the MOU will be KRMU and BRLLP.

**Section-2.0: Objective:**

To develop skilled manpower and to create an ecosystem at par with internationally recognized standards and practices in the fields of finance and wealth management through participatory mode such as seminar, camps, internships, online & offline training programs etc.

**Section-3.0: Engagement and Scope:**

The scope of the Memorandum of Understanding is as under –

1. BRLLP shall/may visit the premises of KRMU and provide awareness sessions/conduct seminar for its students on possible careers in finance and on the ways and means to increase their employability.
2. BRLLP shall/may advise and guide the students on the most relevant training and academic courses available for CFA and other financial certification exams to ensure students can make best decisions in improving their employability.

3. KRMU of its own shall provide a tentative academic calendar for the year, in order to facilitate BRLLP to draw up an effective Awareness/Training Schedule so that it may not coincide with other academic events such as examinations, internal assessments, co-curricular or extra-curricular activities.
4. KRMU will allow BRLLP to conduct marketing activities inside its premises on need basis on mutually agreeable terms and may kindly accord permission to use the logo of KRMU in all our related external communications and vice versa. However, both the parties have the responsibilities for completing the syllabus and arranging for examination/assessment & awarding certificate to already admit successful participants of any courses launched as per this MoU.

#### **Section-4.0: Duration of Engagement:**

This MOU will be valid for a period of 3 years from the date of signing. Once the initial period of 3 years is over, the MOU will be extended for a further period of 3 years, with suitable changes (as per applicability) with mutual consent. If for any reason, any one entity of the MOU is desirous not to continue with the engagement. The same can be done by giving advance notice of one month.

#### **Section-5.0: Dispute & Redressal:**

That this MOU signed between the parties shall cease to exist after mutual agreement between both the parties at any point of time (within its validity period).

In case of any disputes of any kind between the KRMU and BRLLP, the decision of the Vice Chancellor of KRMU shall be final and binding on both the parties.

#### **Section-6.0: Communication**

Both are obliged to communicate with each on regular intervals to plan for and review the results, if available, of conducting the awareness drives, skill camps and other activities. For this both parties will nominate a person as key point of contact.
