MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 12 January 2023

BETWEEN

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE FIRST PART.**

AND

Social Development and Research Foundation (hereinafter referred to as SDRF) was established to undertake research studies, educational activities and all kinds of social and cultural activities which are relevant to the contemporary societal needs in order to strengthen the very social fabric of India. The Foundation vows to render assistance for any public charitable purpose and national cause, and to take up, initiate and assist social development activities or welfare programmes of all possible kinds and in all possible areas for bringing positive change in the lives of the common people. SDRF through its Dr. Sanjay Kumar, Program Director duly authorized in this regard to sign an MOU on behalf of SDRF, **PARTY OF THE SECOND PART.**

The expression KRMU and SDRF shall, mean and include the Institutions/Organizations, their successors, appointees, assignees etc.

KRMU and SDRF are collaborating for Academic Exchange & Cooperation in Education, Research and Training with the objective of building competency, developing teaching skills and moulding the professionalism mindset of teachers through multiple teacher training programs and activities.

Both parties herein agree as follows:

1. KRMU and SDRF will collaborate for knowledge development programmes, training & certification in short term courses and conducting joint inter-disciplinary research.



2. KRMU and SDRF will organize seminars, symposiums, educational activities and other types of professional development activities for faculty and students.
3. KRMU and SDRF will exchange academic materials and publications.
4. There will be no financial liability on part of either party.
5. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
6. This MoU will come into force upon affixing the signatures of the representatives of the partner institutions and will remain in effect for three (3) years.
7. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of three years, it must notify the other institution not less than six months prior to the expiry of the MoU.
8. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.




