MEMORANDUM OF UNDERSTANDING

This **Memorandum of Understanding** (hereinafter called as the 'MoU') is entered into on this day April 1st Saturday, by and between-

AND

Centre of Excellence - KR Mangalam University is the fastest-growing higher education institute in Gurugram, India. Since its inception in 2013, the University has been striving to fulfil its prime objective of transforming young lives through ground-breaking pedagogy, global collaborations, and world-class infrastructure. KR Mangalam University aspires to become an internationally recognized institution of higher learning through excellence in inter-disciplinary education, research and innovation, preparing socially responsible life-long learners contributing to nation building, having its registered office Sohna Rural, Gurugram, Haryana 122103, is referred to as '**Second Party**' company (which expression shall unless repugnant to the context, includes its successors and assignees of the Second Party.)

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')





MEMORANDUM OF UNDERSTANDING

WHEREAS:

- A)** First Party is a CISCO Networking Training Company named: **Network Bullstudy Private Limited.**
- B)** Second Party; **Centre of Excellence - KR Mangalam University**, engaged in some Engineering courses.
- C)** First & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- D)** The Parties intent to cooperate and focus their efforts on cooperation within area of Summer Training, Project Based Training, Industrial Training, Free Technical Workshops & Industrial Visits, Job Oriented Programs for Increasing Employability Skills for Students.
- E)** Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.

CLAUSE – 1

CO-OPERATION

- 1.1) Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of Potential opportunities and shall share all information that may be relevant to secure additional for one another.

- 1.2) First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of the First Party providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of the industry, the Second Party.

CLAUSE – 2

SCOPE OF THE MoU

- 2.1)** Free Networking Career Guidance Workshops/Industrial Visits and Career Counselling.
- 2.2)** Live Project Based Summer Training, internship and Industrial Training Programs; Students pursuing graduation especially – B-Tech/BCA/MCA students can opt for CCNA training program during their summer vacations and the semester breaks. First Party will provide summer training, industrial training, which is entirely project based (Paid Programs).
- 2.3)** First Party (Network Bullstudy) training fee doesn't includes CISCO exam fees.
- 2.4)** Network Bullstudy will provide Training letter, Training Certificate to candidates opting for Summer Training, Internship, Industrial Training (CCNA & CCNA+CCNP programs).
- 2.5)** Depending on the requirement Training can be customized.
- 2.6)** **Industrial Visits:** The First Party will provide Free Industrial Visits, First Party will also provide its Labs / Workshops / Industrial Sites for the hands-on training to the learners enrolled with the Second Party.
- 2.7)** First Party will provide course material for Industrial Training / Summer Training on CCNA & CCNA+CCNP combo programs-paid courses only.





- 2.8)** First Party will require Permission and Space for Two Banners in College premises during the MoU period.
- 2.9)** First party will require space at the college notice board during the MoU period.
- 2.10)** CISCO Networking Lab setup will be done by the First Party (Network Bullstudy). Networking equipment's and tools will be provided by First Party and the Second Party (CoE, KR Mangalam University) will provide the space and systems/computers for the CISCO Lab setup to conduct training programs at college premises. Minimum Students should be 40-50 for training at Second Party premises.
- 2.11)** **Batch Information & Training Calendar:** First Party will send Batch Plan and Training Calendar on mutual agreed training plan with dates.
- 2.12)** **Marketing Support:** First Party will provide Marketing activities like Banners, broachers and leaflets which can also be distributed within Second Party premises to promote registrations of Students. The Institute's website will be updated for the new offerings with mutually agreed structure. First Party will provide marketing support like Posters, Mailers and Banners.

CLAUSE – 3

INTELLECTUAL PROPERTY

- 3.1) Each Party hereby grants to the other, the non-exclusive license rights to the use its name/logo for the purpose of promoting the course and activities under this MoU through public advertisements and through various means including print, electronic, radio, banners, wall painting etc. for the term, Rights and Designs of the other Party.

CLAUSE – 4

VALIDITY of MoU

- 4.1) The Validity of this MoU shall be **One Year (1 Year)** from the day April 1st, 2023_Saturday and thereafter extended through mutual consent.
- 4.2) MoU can be terminated on any unauthorized disclosure of the Confidential Information by the Parties.
- 4.3) Both Parties shall return all confidential information which is in the custody of such Party upon termination/expiry of this MoU and shall not make or retain any copies or record of any Confidential Information, and shall notify the other party promptly of any unauthorized or improper use or disclosure of the Confidential Information.
- 4.4) Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations.




