MEMORANDUM OF UNDERSTANDING (MOU)

This **MEMORANDUM OF UNDERSTANDING** (hereinafter referred to as "MoU") is made and entered into this day of 03 April 2023

BETWEEN

SRM INSTITUTE OF SCIENCE AND TECHNOLOGY (hereinafter referred to as "SRMIST"), whose address is at SRM Nagar, Kattankulathur - 603 203 Chengalpattu District, Tamil Nadu. India and shall include its lawful representatives and permitted assigns;

AND

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956, through its Registrar, presently Gp. Capt. P. Mahajan duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University

KRMU and SRMIST shall hereinafter referred to singularly as "the Party" and collectively as "the Parties".

HAVE REACHED AN UNDERSTANDING as follows:

ARTICLE I OBJECTIVE

The Parties, subject to the terms of this MoU and the laws, rules, regulations and national policies from time to time in force in each Party's country, will endeavor to strengthen, promote and develop relationship and co-operation between the Parties on the basis of equality and mutual benefit.

ARTICLE II AREAS OF CO-OPERATION

1. Each Party will, subject to the laws, rules, regulations and national policies from time to time in force, governing the subject matter in their respective countries, endeavor to take necessary steps to encourage and promote co-operation in the following areas
 - (a) Staff and student's development
 - (b) Joint research activities
 - (c) Joint program and seminar; and
 - (d) Any other areas of co-operation to be mutually agreed upon by the Parties.
2. For the purpose of implementing the co-operation in respect of any areas stated in paragraph 1, the Parties will enter into a legally binding agreement subject to terms and conditions as mutually agreed upon by the Parties.

ARTICLE III FINANCIAL ARRANGEMENTS

1. This MoU will not give rise to any financial obligations by one Party to the other.
2. Each Party will bear its own cost and expenses in relation to this MoU.

ARTICLE IV EFFECT OF MEMORANDUM OF UNDERSTANDING

This MoU serves only as a record of the Parties' intentions and except in relation to Article VII and VIII herein, does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or soto constitute either Party as the agent of the other.


ARTICLE VI DURATION AND TERMINATION

ARTICLE VI DURATION AND TERMINATION

1. This MoU shall commence on the date of its execution by the last Party to sign and shall remain in force for a period of three years. Each Party shall review the status of the MoU at least six months before the end of the three-year period to determine whether it wishes the MoU to continue and, if so, whether any modifications are required. The period of validity of this MoU may be extended by the mutual written consent of both Parties.
2. Each party may to terminate the MoU with or without cause, and without liability of any kind to the other party, by providing three (3) months' notice in advance to the other Party. Upon termination, each party accordingly shall return any document retained by the same to disclosing party.
3. The termination of this MoU shall not affect the validity and duration of any arrangements, activities or programmes which have been agreed upon prior to the date of termination of this MoU until the completion of such arrangements, activities or programmes, unless the Parties agree otherwise.
4. If notice of termination has been given under this clause, the parties shall: a) agree in writing a mechanism for ensuring that students registered for any Programme under this MOU are able to complete it; and b) cease to promote or market the programmes and not register any new students

ARTICLE VII CONFIDENTIALITY

1. Each Party shall undertake to observe the confidentiality and secrecy of documents, information and other data received from or supplied to, the other Party during the period of the implementation of this MoU or any other agreements made pursuant to this MoU
2. For purposes of paragraph 1 above, such documents, information and data include any documents, information and data which are disclosed by a Party (the Disclosing party) to the other Party (the Receiving party) prior to, or after, the execution of this MoU, involving technical, business, marketing, policy, know- 5 how, planning, project management and other documents, information, data and/or solutions in any form, including but not limited to any documents, information or data which are designated in writing to be confidential or by its nature intended to be for the knowledge of the Receiving party or if orally given, is given in the circumstances of confidence.
3. Both Parties agree that the provisions of this Article shall continue to be binding between the Parties notwithstanding the termination of this MoU.

ARTICLE VIII PROTECTION OF INTELECTUAL PROPERTY RIGHTS

3. Notwithstanding anything in paragraph 1 above, the intellectual property rights in respect of any technological development, and any products and services development, carried out –
 - (i) jointly by the Parties or research results obtained through the joint activity effort of the Parties, shall be jointly owned by the Parties in accordance with the terms to be mutually agreed upon; and
 - (ii) solely and separately by the Party or the research results obtained through the sole and separate effort of the Party, shall be solely owned by the Part concerned.





ARTICLE X

VARIATION

ARTICLE XI

GOVERNING LAW AND DISPUTE RESOLUTION

1. Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall be settled amicably through mutual consultation and/or negotiations between the Parties, without reference to any third party.
2. Any consultation and/or negotiation for the settlement of dispute shall be governed by the laws of the country where such dispute arises.

ARTICLE XII

ASSIGNMENT

Unless otherwise agreed in writing, both Parties shall not transfer or assign all or any of their rights, obligations, interests or benefits hereunder to any third party.

ARTICLE XIII

SUSPENSION

Each Party reserves the right for reasons of national security, national interest, public order or public health to suspend temporarily, either in whole or in part, the implementation of this MoU which suspension shall take effect immediately after notification has been given to the other Party.

ARTICLE XIV

ANTI-BRIBERY

1. Each Party represents and warrants that it shall neither take nor refrain from taking any action that could result in liability for the other Party under any anti-corruption or anti-bribery laws and regulations in their respective jurisdictions. Each Party has and shall maintain in place throughout the Term policies and procedures to confirm compliance with applicable Laws relating to anti-bribery and anti-corruption. Each Party shall promptly report to the other Party any request received by such Party for any undue financial or other advantage of any kind in connection with the performance of this Agreement. Neither Party shall accept, offer or make any payment or provide anything else of value, or take or fail to take any other action which is either prohibited or required by applicable Laws in connection with this Agreement.
