
INDIAN INSTITUTE OF INFORMATION TECHNOLOGY SENAPATI & K R Mangalam University

Whereas The Indian Institute of Information Technology Senapati, Manipur (IIITSM) is an institute of national importance established by an act of parliament in 2015 under the Ministry of Education, Government of India. The objective of the institute is to develop a technology and manpower for Information Technology (IT) related industries and make Manipur as a preferred destination for providing IT-related services and gateway to South-East Asia. The IIIT Senapati, Manipur offers B.Tech. programmes in (i). Computer Science and Engineering (CSE), (ii). Computer Science and Engineering (CSE) specialized in AI and Data Science, (iii). Electronics and Communication Engineering (ECE) & (iv). Electronics and Communication Engineering (ECE) specialized in VLSI and Embedded System, and PhD in CSE, ECE and Humanities and Basic Sciences. The city campus is in a prime location at Mantripukhri Imphal, Manipur, India, Pin Code 795002 (about 12km from Imphal Airport), adjacent to New Secretariat of the State and across the Manipur Information Technology Park and Software Technology Park of India (STPI) with ample of opportunities for Entrepreneurship. New campus of IIIT is coming up in 150 acres of land in a scenic slope of beautiful mountains which is well connected through NH2 - National highway at Mayangkhang about 50km away from the Airport

AND

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956. The Governor of Haryana state is the Visitor, presently Padam Shri Prof. Dinesh Singh, Chancellor and Prof. Chandra Shekhar Dubey, Vice Chancellor of the University. University is signing MOU through its Registrar, presently Gp. Capt. P. Mahajan duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University, PARTY OF THE SECOND PART.

The expression K.R. Mangalam University and IIIT, Senapati shall, mean and include the Institutions/Organizations, their successors, appointees, assignees etc.

1. SCOPE OF THIS AGREEMENT

The scope of collaboration on academic and research activities in this Memorandum of Understanding includes the following categories:

- (i) Academic and Research collaboration in the areas of mutual interest. It is expected that this collaboration will in due course lead to collaborative research projects, joint publications, joint workshops and seminars, etc.
- (ii) Scholarly information; materials and publications, Faculty development programs.
- (iii) Use of Science and Technology laboratories for Students, Research Scholars and Faculty Members for academic and research purposes on educational rates.
- (iv) To mentor K.R. Mangalam University under UGC Scheme for Mentoring NAAC Accreditation to promote Quality Assurance as per Paramarsh Scheme.

2. Research Collaboration

Faculty from both Institutions will collaborate in the joint research in disciplines of mutual interest. All such joint research activities will be governed by the terms as given below:

- (i) Proposals for collaborative research work under this Memorandum will be submitted with the prior approval of the Head of each institution, or his/her nominee.
- (ii) Each institution will nominate one of its members as its representative in charge of the cooperative programme. Individual programme of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
- (iii) Procedures followed in any activity under MOU will be reviewed and approved by designated authorities of both parties.
- (iv) Neither K.R. Mangalam University nor IIIT Senapati will be held responsible for any liability to the party, and neither party shall be required to purchase any insurance against loss or damage to any property due to activities to which this agreement relates.
- (v) Every collaboration will have its own agreement / contract which addresses issues such as IPR, funding pattern, usage policies of research facilities, disclosure of information etc.

3. Faculty Collaboration

- (i) Pursuant to the agreement for academic exchange IIIT Senapati and K.R. Mangalam University may invite faculty to deliver guest lectures, organize FDPs and engage in joint guidance of research projects according to the terms mutually agreed by both parties.
- (ii) Participants will be subjected to the rules and regulations of the host institution.

(iii) The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both the parties.

4. Commencement, renewal, termination and amendment


(i) This MoU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for one (1) year. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of one year, it must notify the other institution not less than two months prior to the expiry of the MoU.


