## MEMORANDUM OF UNDERSTANDING

The Memorandum of Understanding is executed on 17<sup>th</sup> day of July, 2023.

### **BETWEEN**

ARCHOVATIONS, Fountain Chowk, Sohna, 122103, Gurugram through Ar. Pearl Sanduja, duly authorized in this regard to sign an MOU on behalf of ARCHOVATIONS (hereinafter referred to as ARCHOVATIONS) **PARTY OF THE FIRST PART.**

### **AND**

K.R. Mangalam University, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 is empowered to award degrees, as specified under section 22 (C) of the UGC Act, 1956, through its Registrar presently Gp. Capt. Praveen Mahajan, duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University (hereinafter referred to as KRMU) **PARTY OF THE SECOND PART.**

The expression ARCHOVATIONS and KRMU, shall, mean and include the Organizations/ Institutions, their successors, appointees, assignees etc.

ARCHOVATIONS and KRMU are individually referred to as "Party" and jointly as "Parties".

And **WHEREAS** both parties have decided and agreed to work on mutually agreed terms mentioned in Articles below

**AREAS OF COLLABORATION:** The following areas of cooperation have been identified under this MoU.

- i. Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge.
- ii. ARCHOVATIONS, will give valuable inputs to KRMU in teaching/ training methodology so that the students fit into the industrial scenario meaningfully.
- iii. The interaction between Industry and Community College Centre will give an insight into the latest developments /requirements of the industries; ARCHOVATIONS, to permit the Faculty and Students of KRMU to visit its group companies and also involve in Professional Training Programs. The professional training and exposure provided to students through this association will build confidence and prepare the students to have

a smooth transition from academic to working career. ARCHOVATIONS, will provide office space for the hands-on training of the learners enrolled with KRMU.

- iv. The scope of collaboration on academic and research activities in this Memorandum of Understanding may include Internship, On Job Training, Student/Faculty Exchange in the following categories.
- v. ARCHOVATIONS, will train the students of KRMU on the emerging technologies to bridge the gap in skill and make them ready for industry.
- vi. ARCHOVATIONS, will extend the necessary support to the students of KRMU on the technology trends and in house requirements.
- vii. ARCHOVATIONS, will actively engage to help the delivery of the training and placement of students of KRMU into internships.
- viii. ARCHOVATIONS, will provide certification to acknowledge and appreciate student's work.
- ix. ARCHOVATIONS, will exchange students, teachers and professionals to organize guest lectures, symposiums, seminars, conferences, and other types of professional development activities for faculty and students.
- x. ARCHOVATIONS, will exchange academic materials and publications
- xi. Academic and Research collaboration in the areas of mutual interest. It is expected that this collaboration will in due course lead to collaborative research projects, joint publications, joint workshops and seminars, etc.
- xii. ARCHOVATIONS, will jointly conduct research projects and publications with faculty and students research projects and publications with faculty and students.
- xiii. Scholarly information; materials and publications, Faculty development programs.

**PREAMBLE:** The purpose of this Memorandum of Understanding (MOU) is to develop academic and educational cooperation, and mutual understanding between ARCHOVATIONS, and K R Mangalam University (hereinafter referred to as KRMU), Haryana, represented by its duly authorized signatory, the Registrar.

The primary objective of the collaboration to promote interaction and academic partnerships between faculty and students of the two institutions through visits, guest lectures and internship programs, sharing of industrial resources through expert talks, visits, reviews, internships etc. The relationship also aims at enhancing the technological, social, and cultural relations of both regions. This document presents a general framework for the collaboration. It also includes some specifically identified areas of cooperation, which may be updated from time to time.

**COORDINATION:** The provisions of this MoU will be implemented through a team of coordinators (faculty and students) appointed by the authorized signatory from both parties.

**SCOPE OF COOPERATION:** The areas of cooperation may be revised by mutual consent. However, specific programs may require separate agreements detailed out and documented as annexures to this MoU.

**NON-DISCRIMINATION:** ARCHOVATIONS, and KRMU agree not to discriminate any person because of age, sex, national origin, race, ancestry, color, religious creed, disability or handicap, and sexual orientation. Neither institution shall impose criteria for the exchange of faculty, staff and students that would violate the principles of non-discrimination.

**CODE OF CONDUCT:** Visiting student and faculty will abide by the code of conduct of the host Institution. The parties should ensure that the faculty and students are made aware of the rules, regulations and other administrative procedures prior to the application and approval.

**INTELLECTUAL PROPERTY:** The intellectual laws of the Nation will be respected and adhered to by both the parties. The two parties may jointly own the results or data generated during the collaborative projects; however, the host institution will govern the protection and commercialization of data or any intellectual property created during any of the aforementioned modes of cooperation.

Non closure agreements may be encouraged between the parties to clearly state the necessary and reasonable care to be taken to protect data or information.

**FINANCING:** Under this MoU, it is understood and agreed that there is no financial obligation between the parties. Additional support, if any, will be governed by separate agreements that may be drawn up for specific activities.

**LEGAL STATUS:** This document is a statement of intent to foster genuine and mutually beneficial cooperation and is not legally binding on any of the parties. Any disputes shall be resolved only through mutual discussion.

- b. on written notice by one of the Parties if the other Party has committed a breach of this MoU.

However, specific commitments made prior to such intimation shall be honored by both the partners including ensuring that any student at that time participating in the Program is able to complete the term of the assignment and be assessed for it.
