



## **MEMORANDUM OF UNDERSTANDING**

The Memorandum of Understanding is executed on 14 day of August, 2023.

### **BY AND BETWEEN**

**K.R. Mangalam University**, Sohna Road, Gurgaon - 122103 (Delhi NCR Region), a University established under the Haryana Private Universities Act 2006 (Amended 08 of 2013) and under section 2(f) of UGC Act, 1956 wherein empowered to award degrees, as specified under section 22 of the UGC Act, 1956. The university is signing MOU through its Registrar, presently Gp. Capt. P. Mahajan is duly authorized to enter into and sign an MOU on behalf of K.R. Mangalam University, **PARTY OF THE FIRST PART**.

### **AND**

### **1. SCOPE OF THIS AGREEMENT**

- (iii) The company would allow the university to use its Brand Logo and Name for the University Website and other promotional activities and vice-a -versa.


### **2. COMMENCEMENT, RENEWAL, TERMINATION, AND AMENDMENT**

its expiry, with the agreement of both the partner institutions. Either party can cancel the MOU at any time, though a month's advance notification will be preferred.

This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties. This MOU is not a legal document.
