

Both parties herein agree as follows:

1. KRMU and Sociwind Foundation will collaborate for knowledge development programmes, training.

3. KRMU and Sociwind Foundation will engage in training programmes, research projects and publications with faculty and students.
4. KRMU and Sociwind Foundation Chapter will exchange academic materials and publications.
5. There will be no financial liability on part of either party.
6. The scope and duration of the collaboration may be amended and/or extended through the joint agreement further with the consent and approval of both parties.
7. This MoU will come into force upon affixing the signatures of the representatives of the partner institutions and will remain in effect for three (3) years.
8. This MoU may be renewed upon its expiry, with the agreement of both the partner institutions. If either partner institution wishes to terminate the MoU at the end of ONE year, it must notify the other institution not less than two months prior to the expiry of the MoU.
9. This MoU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.


