# DEMOCRACY IS IN INDIA'S DNA: MODI

GE Aerospace-HAL to make jet engines for IAF, NASA-ISRO's mission to Space Station in 2024, new H-1B visa rules among several pacts inked

As India and the US wrapped up several major defence deals on Thursday, taking the ties between the two countries to new heights, Prime Minister Narendra Modi reached out to his critics in the USA by insisting that there is no discrimination on the basis of religion or caste in India. He stressed the country is run on the basis of the constitution and strong fundamentals of democracy, which is in its DNA.

Modi made this categorical assertion in Washington when asked about the status of religious minorities, including Muslims, during a media interaction after the summit with President Joe Biden. He also said that relations with the US are at a stage where "the sky is not the limit," as he mentioned in the joint press conference with Blinken.

"We are a democracy... India and America both have democracy in our DNA. Democracy is in our spirit, and we live it. It's written in our Constitution. So, no question of discrimination on the grounds of caste, creed, or religion arises. That is why India believes in 'sabka saath, sabka vikas, sabka vishwas, sabka prayaas' and walks ahead with it," Modi said when asked about steps the Government is willing to take to improve the rights of

minorities in the country. Modi also said that the two countries discussed the entire spectrum of issues relating to their bilateral relations and the ongoing Ukraine crisis. He reiterated that India has always maintained that peace and dialogue are the way out to resolve the conflict and that the country is ready to do its part in

restoring peace. Highlighting the growing defence ties between the two has shifted from a buyer-seller relationship to joint production and development of weapon systems. He also welcomed the move to manufacture GE-414 jet engines in India, describing it as a landmark agreement that will also

provide jobs. Brushing aside apparent apprehensions of human rights violations in India, Modi stated that democracy in the country is based on respecting



rights.

The PM said that India and the US have "overwhelming respect" for each other because "we are democracies, and it is in the US and India's DNAs to expand democratic institutions."

When asked about religious minorities and dissent by a US reporter, Modi said, "Regardless of caste, creed, religion, gender, there's absolutely no space for dis-crimination." He also emphasised that resources and benefits are available to all, irrespective of caste, creed, religion, or gender, adding that there is no discrimination

Biden said he discussed the issue of human rights in a straightforward manner with that democracy is in the DNA of both countries. He went on to add, "So, I am really surprised when people say so (discrimination against minorities). India is a real democracy," he said, adding there is no space for discrimination in a democracy, and India believes in moving forward by taking

everyone along. Answering a question on the effects of climate change, Modi said, "We do not believe

human values and human in the exploitation of nature. Of all the G20 countries, India is the only country that has fulfilled all the promises made during the G20 Summit. We are working to make India a green energy hub.... The environment is an article of faith for us. We do not believe in the exploitation of nature?

Meanwhile, underlining some other issues discussed during the summit, the Prime Minister said that the two countries also agreed on the Artemis accord on space and remarked that "the sky is not the limit" in their relationship.

Additionally, the National Aeronautics and Space Administration (NASA) and the Indian Space Research Organisation (ISRO) have agreed to collaborate on a joint

Space Station in 2024. The Artemis Accords, rooted in the Outer Space Treaty of 1967, provide a framework of non-binding principles to guide space exploration and utilisation in the 21st century. Led by the US, the Artemis program aims to return humans to the moon by 2025, with the ultimate objective of expanding space explo-

### Modi meets US tycoons, invites Micron to boost semiconductor making in India

#### **PM highlights India's** competitive advantages

Prime Minister Narendra Modi met with CEOs of prominent US companies in Washington on Thursday, where he extended an invitation to American chip maker Micron Technology to bolster semiconductor manufacturing India's competitive advantages across various segments of the

semiconductor supply chain. He also invited Applied Materials to invest in India for the development of process technology and advanced packaging capabilities. During his discussion with Gary E Dickerson, President and CEO of Applied Materials, Modi explored the potential of collaboration between the company and Indian academic



institutions to cultivate a skilled conductor assembly and test

In terms of semiconductor development, US companies are partnering with India to establish an ecosystem that promotes supply chain diversification. Micron Technology, with support from the Indian National Semiconductor Mission, announced an investment exceeding \$800 million.

With additional financial backing from Indian authorities, the total investment will amount to a \$2.75 billion semi-

In addition, Applied Materials unveiled plans for a new semiconductor center dedicated to commercialisation and innovation in India. Lam Research, another semiconductor manufacturing equipment company, is set to announce a training programme for 60,000 Indian engineers through its semiverse solution, aimed at accelerating India's semiconductor "On critical minerals and mineral security, the United States will announce its support for India becoming a member of the Mineral Security Partnership led by the US State Department." This partnership aims to

strengthen the critical minerals supply chain and ensure an adequate supply of essential minerals for climate, economic, and strategic technology objectives," a senior administration official said.

Affairs confirmed the Prime Minister's invitation to Micron Technology, stating, Prime Minister invited Micron Technology to boost semiconductor manufacturing in India." Following the meeting, Micron Technology CEO Sanjay Mehrotra expressed enthusiasm about the opportunities in India, highlighting the company's global leadership in memory and storage.

According to the Uttar Pradesh Real Estate Regulatory Authority (RERA), the buyer had booked the flat in Mahagun Mezzaria in Sector 78 of Noida in 2017 and paid ₹1.35 crore to its promoter, NexGen Infracon.

The promoter had promised to deliver the flat in December 2018. # 5L hit, 1 dead as Assam flood situation worsens

¬he flood situation in Assam deteriorated drastically on Thursday with one person losing his life and nearly five lakh people reeling under the deluge across 12 districts, an official bulletin said.

According to the daily flood report of the Assam State Management Disaster Authority (ASDMA), one person died due to flooding in Tamulpur of Udalguri district.

This is the first official record of death on account of flood this year, an ASDMA official said.

The report said over 4,95,700 people are hit due to the floods in Baksa, Barpeta, Chirang, Darrang, Dhubri, Dibrugarh, Kamrup, Kokrajhar, Lakhimpur, Nalbari, Sonitpur and Udalguri districts.

Barpeta is the worst hit with over 3,25,600 people suffering, followed by Nalbari with more than 77,700 people and Lakhimpur with around 25,700 people suffering, it added.

Till Wednesday, nearly 1.2 lakh people were suffering from floods across 10 districts of the state.



The administration has been operating 83 relief camps in seven districts, where 14,035 persons have taken shelter, and running 79 relief distribution centres in eight districts.

Paramilitary forces, NDRF, SDRF, Fire and Emergency Services (F&ES), civil administrations, NGOs and locals have rescued 561 persons from different places. The administration has distributed 1,265 quintals of rice, dal, salt and 5,269.80 litres of mustard oil among the flood victims during the last 24 hours.

At present, 1,366 villages are under water and 14,091.90 hectares of crop areas have been damaged across Assam, the ASDMA said.

He said India achieved the target of 40 per cent of its installed electricity generation capacity being from non-fossil energy sources nine years ahead of schedule.

As part of its updated nationally determined con-tributions or national plans to fight climate change, India now stands committed to achieving about 50 per cent cumulative electric power installed capacity from nonfossil fuel-based energy resources by 2030.

With an installed renewable energy capacity of 175.74 hydro), which is about 42.6 per cent of the country's total capacity (as on March 2023), India stands fourth in the world, the minister said.

"Its installed renewable energy capacity has increased by 396 per cent in the last nine years," Yadav told a press

# LG flags inordinate delay in Govt's hospital projects

Delhi Lieutenant Governor Vinai Kumar Saxena on Thursday dashed off a letter to Chief Minister Arvind Kejriwal flagging "inordinately delayed' hospital projects in the national Capital, alleging that the intention of the government has been only to create "publicity-supported hype" in public domain.

Sharing a list of 19 projects related to hospitals, Saxena alleged that the AAP government's claims about a revolution in the health sector are

Highlighting the "importance of execution over announcements", Saxena in his letter said it is starkly evident in the present case that the "intention of the government has been nothing but creation of publicity-supported hype in public domain".

"Rampant inaction on ground leads to the hype so created not getting fructified," he added. The LG further claimed that nothing big happened in the health sector despite big claims from the Delhi government. Saxena said

According to a statement from the Krantikari Yuva Sangathan (KYS), on June 3, an event organised to distribute degrees to a limited number of students graduating from the varsity was called off by the SOL as scores of students gathered at the venue believing that all of them will be conferred with a degree.

Payal Mago, Director of Campus of Open Learning, said an advisory has been issued after chaos erupted at the SOL centre as a number of students, including those of previous years, gathered to collect their degrees even though only a limited number of students were called. "We had



to distribute 75,000 degrees during the fair. The degrees were being distributed on an appointment basis for which students were asked to fill a google form days before the event. And we had decided to distribute the degrees in batches," said Mago.

However, some Youtube channels and Whatsapp group spread false information that all, including the previous-year students, can turn up to collect their

degrees. We somehow managed the situation," she added. SOL said, "All concerned may please note that the distribution of degrees for passing out students of 2022 of SOL through the 'Degree Fair' scheduled on June 3 and 4 has been stopped with immediate effect due to unavoidable cir cumstances.

The notification further said, "The degrees will now be sent by post to the addresses of the students shortly." In a note addressed to its present and former students, SOL accused some YouTubers of gathering information from its official website, adding that after reframing that information, the social media influencers posted them on their channels and other groups in the "wrong manner".

#### Ex-pharmacist arrested for storing illegally banned 36K bottles of cough syrup

former pharmacist was Aarrested for allegedly storing more than 36,000 bottles of banned codeine-based cough syrup in a warehouse at Azadpur, police said on Thursday. Cough syrups with an ingredient of codeine phosphate have an intoxicating effect on nerves and they are widely abused due to easy availability at pharmacies. The government has banned codeine-based syrups.

The drug license of the accused was cancelled twice in the past due to irregularities, officials said, adding that the grey market value of the seized syrup is around Rs 1 crore.

On June 16, information was received that a huge consignment of psychotropic substances was lying in a ware-house inside Aradhana Bhawan, Azadpur, police said. A raid was conducted and 36,238 bottles of 'Byerex' syrup, illegally procured and stored in the warehouse, were seized at the instance of warehouse occupant Vipin Chawla, Special Commissioner of Police (Special Cell) H G S Dhaliwal said. The bottles were kept in 302 cardboard boxes, he said.

Chawla could not produce any document for valid possession of the syrup bottles which were procured and stored for illegal sale and drug abuse, police said.

Chawla was involved in the


wholesale business of medicines for the last 12 years. Initially, he used to purchase medicines authorised/legal distributors and would supply to local

### 'Computer system to be used for water supply monitoring'

Delhi Chief Minister Arvind Kejriwal on Thursday said the Delhi government will use special computer systems called SCADA to monitor the water supply more efficiently from July 1. This will help make sure water is distributed properly across the city, an official statement quoted Kejriwal as saying.

To make this monitoring possible, flow meters will be installed on the water pipeline network by the end of this year. These meters are connected to the SCADA system, which allows the Delhi Jal Board (DJB) headquarters to keep an eye on how much water is flowing in each pipeline all over Delhi, the statement said. SCADA systems are like smart

the water system. They allow the people in charge to watch over everything from one central location, it said.

During a meeting with DJB officials, Kejriwal emphasised the government's commitment to preventing wastage of water in Delhi. The DJB, in a statement, said it has been found that there are no proper records of water availability in the city.

Although water is being supplied to different areas, it is not being properly recorded. Over the years, the main water lines have been tapped and changed, causing some areas to receive low or no water pressure, it said. The government is thus installing flow meters to

# Manipur, seeks Modi's presence

The Centre's decision to convene an all-party meeting chaired by Home Minister Amit Shah to discuss the ongoing crisis in Manipur has sparked criticism from some Opposition parties, who are demanding the presence of Prime Minister Narendra Modi.

The meeting, scheduled for Saturday, aims to address the ethnic clashes in the northeastern state that have resulted in over 110 deaths since May 3.

The Ministry of Home Affairs announced the meeting through a tweet, stating, "Union Home Minister Amit Shah has convened an allparty meeting on June 24th at 3 PM in New Delhi to discuss the situation in Manipur." The announcement came shortly after Assam Chief Minister Himanta Biswa Sarma met Shah in the national capital late Wednesday night.

The Congress party criticized the all-party meeting, deeming it "too little, too late." They argued that discussions held in Delhi would lack seriousness and called for efforts to bring the warring factions to the discussion table. The party also pointed out that the meeting was scheduled only after former Congress President Sonia Gandhi expressed her concern over the turbulence in the northeast region.

Opp raps Shah's all-party meet on

In response, the BJP accused the Congress of making the "too little, too late" remark to create grounds for boycotting the meeting and avoid accountability.

Amit Malviya, the head of BJP's IT department, alleged that the violence in Manipur is a "legacy" of the Congress, as ethnic conflicts were sown when the party was in power at both the central and state lev-

"The Congress first demanded an all-party meeting, and now, when one has been announced, it is creating grounds to boycott it just two days ahead of the meet. It is obvious that the Congress' intent is not to find a solution, avoid accountability, and keep the pot boiling," claimed the BJP leader in a Twitter post.

Senior BJP leader and Maharashtra Deputy Chief Minister Devendra Fadnavis asserted that Home Minister Amit Shah is capable of handling the situation in violencehit Manipur, eliminating the need for the Prime Minister to visit the northeastern state.

This statement came in response to criticism from Shiv Sena (UBT) president and former Chief Minister Uddhav Thackeray, who questioned why Prime Minister Modi was undertaking a tour of the US instead of visiting Manipur to restore peace.

Former Congress President Rahul Gandhi suggested that the absence of the Prime Minister during the all-party meeting indicates its lack of importance to him. He highlighted that Manipur has been engulfed in unrest for 50 days, but the Prime Minister has remained silent.

Congress General Secretary KV Venugopal emphasized the need for a meeting at the Prime Ministerial level, specifically in Manipur. He urged the Prime Minister to prioritize the peace and well-being of the state.

The opposition's demand for the Prime Minister's presence adds a new dimension to the upcoming all-party meeting, raising questions about the level of engagement and accountability in resolving the

#### **CBI** to probe Lady Singham's death in **Assam road mishap**

The Central Bureau of Investigation (CBI) has taken over four separate cases connected to the death of Sub-Inspector Junmoni Rabha of the Assam Police. Her demise, believed to be the result of a road accident, occurred last month. Officials have stated that the agency will soon summon individuals for questioning and will also meet with the doctors who conducted Rabha's

Junmoni Rabha, popularly known as 'Lady Singham' or 'Dabang cop,' lost her life on May 16 in the early hours of the morning. Her vehicle collided head-on with a container truck in Sarubhugia village, located in the Kaliabor subdivision of Nagaon district

Soon after Rabha's death, the circumstances surrounding the accident were contested by her mother. In an FIR, she alleged that Nagaon Superintendent of Police Leena Doley conducted a raid at their house between 1 AM and 2 AM on May 16, shortly after Rabha's demise. According to complaint, Doley compelled her to sign certain bank documents

and also seized ₹4.30 lakh in

cash during the raid. The mother further asserted that Doley did not inform her about Rabha's death. It was only after daybreak that another police official informed her about the accident. The mother also claimed that Rabha had been killed and exhibited injury marks on her body. The ĆBI's special crime unit has now taken up the investigation into Rabha's death, as well as two additional cases.

One case pertains to a fake currency racket that was exposed by Nagaon Police on May 5 based on information provided by Rabha. The other case was filed against Rabha by a family member of individuals under scrutiny in fake currency probe. In this case, the complainant accused Rabha of raid ing her residence on May 6 at 2 AM, holding her son captive, and extorting over ₹6 lakh from

According to the allegations, Rabha, along with seven others, raided in Lakhimpur district, which is 200 kilometers away from her place of posting. During the raid, the police team reportedly assaulted the complainant, abducted her son, and seized ₹80,000 in cash, jewelry, and a Maruti Brezza car.

### BJP warns of satyagraha if Sidda fails to implement 5 poll guarantees in K'taka

The BJP has warned the Siddaramaiah Government on the fulfillment of "five guarantees" in the state with veteran party leader and former Karnataka Chief Minister BS Yediyurappa on Thursday announcing 'Satyagraha' both inside and outside the Assembly, if the dispensation fails to implement pollpromises before July three when the new Legislature is to begin its session.

BJP has maintained that barring 'free-ride" to women in the state buses, the Congress has failed to implement other four guarantees it promised to the voters of Karnataka. The opposition party is expected to intensify its protest with an eye on the Lok Sabha poll which is barely 10-11 months away. Karnataka sends 28 MPs to the Lok Sabha.

Yediyurappa also hit out at the Chief Minister and his government for "unnecessarily blaming" the Centre regarding the supply of rice for the State's "Anna Bhagya" scheme, calling it an "unpardonable offence and "betrayal to the people". "Purposefully, attempts are being made by Siddaramaiah (CM) and Shivakumar (DCM) to point fingers at the Centre with regards to rice. Central



Government is already giving 5 kgs of rice for free. If they want to give additional quantities of rice, the state government should purchase rice to make arrangements for its supply; instead they are making false promises," Ýediyurappa said in Davangere central Karnataka.. The former Chief Minister

warned the Congress government in Karnataka that his party will stage 'Satyagraha' (protests) both inside and outside the Assembly, if it fails to implement the five poll guarantees before the Legislature session, and asked it to quit, if not able to fulfill the promises.

"Implementing guarantees will lead to shortage of funds for developmental activities. There are already protests against the raise in power tariff. Congress is in a way enjoying power by troubling the people. I condemn it. People will respond to it," he said. The former Chief Minister said he too will stage demonstrations in front of

'Vidhana Soudha', the seats of state Legislature and Secretariat in Bengaluru. He said the Congress had given five poll promises, among them only the free bus service scheme for women has been launched and it is operational, amid a lot of hindrances.

"If the other four guarantees are not implemented before the Assembly session begins, it will be inevitable for us to stage 'Satyagraha' inside and outside the House (Assembly). I'm also ready to stage a 'dharna' (demonstration) in front of Vidhans Soudha. So immediately they (Congress) should fulfill their poll guarantees," he

The new Karnataka Legislature Session is scheduled from July 3 to 14, which will also see the new government tabling a fresh budget. The BJP agitations will be planned by the party legislators and leaders, and every one of them will be participating in it, Yediyurappa said.

# **Naturopathy mentioned in** Vedas, Puranas: UP Guv

overnor Anandiben Patel Ginaugurated the 40th National Conference of the All India Naturopathy Council on the subject of 'Indian Knowledge Tradition and Gandhian Way of Naturopathy' at Gandhi Ádhyayan Peeth auditorium in Mahatma Gandhi Kashi Vidyapith (MGKV) here on Thursday. The conference was organised under the joint aegis of All India Naturopathy Council and Yoga and Naturopathy Education Centre, MGKV.

Addressing the conference, the Governor said that naturopathy is an ancient system of medicine, which is mentioned in our Vedas and Puranas. "Its emergence has happened with nature itself. It is not just a resource for the diagnosis of diseases but a philosophy of life. The effect of the Indian system of medicine was seen during Covid pandemic where medicines were not working while herbs and yoga made invaluable contributions in saving life," she said, adding that Gandhi has been considered the first doctor of naturopathy in the modern Indian system of medicine. "We abandoned our traditional food tradition and started taking junk food and its side effects today," said

# After Ajit, Bhujbal stakes claim to NCP chief's post

day after senior state ANationalist Congress Party (NCP) leader and current leader of the Opposition (LoP) in the Maharashtra Assembly Ajit Pawar indirectly staked a claim for the State party president's post, senior NCP leader and former deputy chief min-ister Chhagan Bhujbal said here on Thursday that an OBC leader should be considered for the State party chief's post.

A leading OBC leader and founder-President of Akhil Bhartiya Mahatma Phule Samata Parishad, Bhujbal made a counter-claim for the State NCP chief's post, saying: "If the LoP is with Marathas, then the state party's chief should go to an OBC community or to a smaller community'

Apparently alluding to remarks made by Ajitdada – as Ajit Pawar is known in the state political circles, Bhujbal said here on Wednesday "Óur party has internal democracy. Everyone has a right to express his right to express his opinion. We have someone who wants to occupy a different position and wants to work within the party. I also want to express my opinion. I was made the state party president in the past for a brief period of four months. As a consequence, the BJP also made an OBC leader like Babankule as the state party president?

"Our party also has OBC leaders. We have leaders like Sunil Tatkare, Dhanjay Munde and Jitendra Awahad... If I am given responsibility in the party I will also work... I strongly feel that a leader from the OBC community should be made the state party president," Bhujbal said.

Interestingly, party leaders like Tatkare and Awhad were vested with party posts at the national level, when NCP chief Sharad Pawar carried out an organisational re-jig on June 10.

While it is not clear yet if Bhujbal's claim for the post of state party chief is genuine one or an orchestrated one made with an intention to nullify Ajitdada's claim for the state party president's post.

#### Sena (UBT) accuses Shinde's family of role in Covid-19 fake bill scam

the Enforcement Directorate (ED) raided 14 locations in Mumbai, including the premises of those close to him and his party leader Aaditya Thackeray in connection with an alleged Covid 19-scam related money laundering case, Shiv Sena (UBT) MP and spokesperson Sanjay Raut on Thursday charged that the family members of Maharashtra chief minister Eknath Shinde benefitted from a scam of severe crore of rupees in his home district of Thane.

Talking to media persons here, the Sena (UBT) spokesperson alleged that Shinde;s family members were involved in were related purported fake bills which were issued by certain companies for Covid-19 facilities at Thane and the neighbouring Kalyan-Dombivali towns.

"I am speaking on the basis of evidence. Fake bills for crores of rupees were raised for providing the facilities. The alleged fake billing benefited Shinde's family at that time," Raut said,

Waving a bunch of documents and seeking an immediate reply to his allegations from the authorities concerned, Raut said: "The ruling Shiv Sena should first introspect themselves and their alleged involvement in the scam before hurling allegations at others".

Raut's allegation came on the heels of the ED raiding several locations in connection with the Covid-19 scam related money laundering case and also the State government's decision to order an SIT probe into the large-scale financial irregularities that took place during the Covid-19 period.

### **Democracy at gunpoint**

Violence is rampant and threats are flying in the air in West Bengal before the panchayat elections

fter the Supreme Court's Vacation Bench's decision to uphold the Calcutta High Court decision, West Bengal would have the Panchayat elections under the shadow of central security forces. The central forces would ensure free and fair panchayat elections on July 8. They would not be deployed on the polling stations alone but across the state to maintain law and order. The SC Bench maintained that the state has a "history of violence" during local polls. The Panchayat elections in Bengal are a mammoth exercise involving elections to 75,000-odd seats. The polling would take place across 61,636 booths in the State in just one day. The supreme court maintains that "Holding an election cannot be a license for violence." The supreme court order effectively takes away the state's role in maintaining the law and order in the state. The apex court summarily rejected the West Bengal contention that only 189 booths out of 61,000 were identified as sensitive and ignored the fact that the State had over 50,000 police



personnel to watch over the 189 booths. It is unfortunate that the courts have to intervene at every step to ensure free and fair elections which is ideally the duty of the election commission which can direct the central and the state government to make adequate arrangements for providing an atmosphere where people can cast their vote without fear.

But, there is definitely merit in Congress's contention that there is an atmosphere of fear in the state. Around 4,800 candidates - 1,500 of them from BJP backed off from contesting panchayat elections on the last day for withdrawal of nominations; many of them citing "pressure" as a reason for their withdrawal. Now just

over 2 lakh contestants are left in the fray amid continued violence in some rural pockets. Five Congress workers, including a former MLA, were wounded in a clash in front of the block development office at Murshidabad's Burwan after goons snatched poll documents from candidates. BJP and Congress drove candidates into party offices or set up camps to protect them from TMC cadres who were allegedly threatening them to withdraw their candidature. A total of 670 Independents, mostly disgruntled TMC workers who had decided to go solo after being denied tickets, also backed out of the poll. The situation is so bad that Bengal Congress chief Adhir Chowdhury sat in protest outside the BDO's office, accusing "TMC-backed miscreant" of fomenting trouble to win seats in Burwan. The violence in West Bengal's Panchayat elections is a grim reminder of the challenges faced by the democratic process. Breaking this cycle of violence requires a multi-faceted approach that addresses political polarisation and strengthens law enforcement. The Onus lies with the Bengal Chief Minister Mamata Banerjee who should ensure that TMC cadre does not hamper the voting process. Bengal is one of the few states in the country where grassroots democracy thrives but it must be ensured that it is free and fair and not achieved through intimidation which smears the whole process.



The question of accountability

The very foundation on which democracies thrive is the rule of law, and that hinges on the simple premise that nobody is above the law

omparisons of where we stand in the rankings as a democracy, based on the likes of the Economist's Democracy Index, are obviously subjective and possibly biased to an extent. The only test that truly counts in these matters is whether those elected can be held accountable for actions while in office. The very foundation on which democracies thrive is the rule of law, which is premised on the belief that actions have consequences and nobody is above

Former President Trump is finally learning this the hard way. Facing trial for allegedly stealing classified government documents, which if proved, may well see him behind bars. This is what accountability looks like in a working democracy, though Americans are not without their own set of challenges. Mr Trump remains extremely popular with the vast majority in the Republican Party, mainly white Anglo-Saxons, who, fearful that their power is rapidly slipping away as the country becomes more diverse, are willing to overlook his transgressions and forego their democratic values.

On applying similar norms to ourselves, despite our claims of being the largest democracy, we are clearly on life-support. Blatant obfuscation of facts, police connivance and judicial apathy, to give the judiciary the benefit of the doubt, ensure that our leaders are never held accountable, however revolting, corrupt or self-serving their actions may have been. In fact, the rule of law remains a mirage for the vast majority of our citizens. Examples over the years are too numerous to quote, the latest being that of Mr Brij Bhushan, the Chairman Wrestling Federation of India, and his alleged misbehaviour with women wrestlers.

Similarly, heads have not rolled over the tragic Orissa train accident. A foreign hand is suspected of sabotage, opening an escape avenue for those responsidie. The fact that the Kallway Board had pointed out shortcomings in the maintenance of signalling equipment that led to five similar incidents earlier, of vary-

ing degrees of seriousness, has been blithely ignored. As has been the CAGs report points out the misuse of funds, meant for maintenance and replacement of tracks, on items unconnected to maintenance. Despite this rather grim state of affairs, the Railways are busy promoting the Prime Minister's pet project, flag-ging off more Vande Bharat train sets, travel on which, to use Mr Tharoor's obnoxious phrase, the 'Cattle Classes', can ill afford. Instead of accepting responsibility and resigning, the railway minister seems comfortable, shamelessly meddling in the CBI investigation.

For that matter take the events unfolding in Manipur. Clearly, this is the "Bhindranwale moment" for Mr Modi's government, as their man on the spot has gone rogue. involved in drugs and arms smuggling and human trafficking, should not be under-

In military circles, civil war is seen as the culmination of any insurgency, with insurgents confident enough to forsake guerrilla tactics and take on government forces head-on, with secession being their ultimate goal. While the situation in Manipur may not yet be so dire, instances of militants, especially Meitei Groups, confronting Army/Assam Rifle contingents openly have been reported. Undoubtedly, the huge quantity of sophisticated arms "looted" from police armouries gives these militants confidence, as must the fact that the military has not been given a free hand to act.

Yet, despite the ongoing violence, the significance of the government has made no serious efforts to salvage the situation, by either sacking the Chief Minister or declaring President's Rule, as well as the Prime Minister's unwillingness to engage or address the situation cannot be lost on anybody. Ironically enough, he has offered to mediate between Ukraine and Russia and his loquaciousness on American sojourn is difficult to miss. Clearly, the government appears to be complicit in pushing through some mis-



conceived ideological agenda, despite the cost to the Nation. a cost that our Security Forces and citizens will continue to pay in blood and shattered lives in the coming months and vears.

Let there also be no doubt that given the strategic importance of the region, it is only a matter of time before the Chinese commence pouring oil on troubled waters, if they have already not begun doing so. It seems that the Prime Minister is deliberately avoiding involving himself, in the vain hope that either the troubles will resolve themselves over time, or they can be left to his underlings to solve. Like many before him, he appears to have fallen into the Nehru trap of wanting to gain international recognition and respect by focusing on larger issues afflicting our world. Unsurprisingly, just like Nehru, he is likely to be overwhelmed by firestorms at home and find his legacy tarnished by his reluctance to confront China as it continues with its depredations on our sovereignty.

#### **INDIA-US RELATIONS: HEADING NORTH**

PM's state visit takes India-US relations to the next

t was nearly a decade and a half ago, when US President Barrack Obama, chose to have PM Manmohan Singh as the first state visit of his administration, thereby underlining a significant upgrade to the India-US bilateral relationship. Many officials at that time had described the invite to India, not as an accident but as a carefully thought gesture, to bring a friend closer to Asia. 2009 wasn't the time when the US-China relationship, or the India-China bilateral was unstable, yet, both countries realised the future threat and started deepening their bonds.

This week the spectacle that unravelled before citizens of both countries with PM Modi's state visit to the US, the address by the Indian PM to the joint Congress, the curated business meetings with top CEOs and the rock star level diaspora events, are a couple of decades of relationship reset, now, visible. It may be worth remembering that just two and half decades back India was under US sanctions and there was almost a diplomatic freeze in relations, haunted by memories from the cold war. There was resistance (perhaps there is still some resonance of the initial fears) nursed by some old-world think tanks, academicians and strategists on both sides.



However, the relationship, one which is transformational and crafted for the 21st century has been expanded to include a vast spectrum of shared interests, which are difficult to be ignored in the next couple of decades. The political economy of both democracies has also accepted the new reality and there is bipartisan support for enhanced closer India-US partnership.

If one of the key opposition leaders, Rahul Gandhi was in the US a fortnight before the PM's visit, engaging with think tanks, government officials and the diaspora on the state of Indian democracy, the US congressional leaders meanwhile, led by the Speaker of the House of Representatives Mr Kevin McCarthy and Senate Majority leader Mr Charles Schumer, extended a rare invite for an Indian PM to address the joint sitting of congress, for the second time. The political message was loud, both countries acknowledge the relevance of each other in the new world order.

This state visit underscored the shift in India-US bilateral from primarily being focussed on a strategic defence partnership to taking giant steps towards a meaningful technology partnership. As PM Modi in his remarks before flying to the US noted "India-US ties are multifaceted, with deepening engagements across sectors. The USA is India's largest trade partner in goods and services. We collaborate closely in science & technology, education, health, defence and security fields. The initiative on Critical & Emerging Technologies has added new dimensions and widened collaboration to defence industrial cooperation, space, telecom, quantum, Artificial Intelligence and biotech sectors."

One of the most significant fillips to this new age partnership has been the creation of iCET ( initiative on critical and emerging technologies), a platform, supervised by the Indian Prime minister and US President's office directly. US National security advisor, said "ICET is foundational, fundamental, critical because we believe that the future of our economies, societies security sectors will be determined by the extent to which we can effectively harness emerging technologies on behalf of our people and on behalf of our national interests." The markers have been set, the sprinters are in position, and perhaps the gunshot has been fired for the long haul US India cross country run for decades to come.

# MSP guarantee will spell disaster for farmers-



The hapless farmers must be liberated from the stranglehold of cartel licenced traders by giving them options to sell their produce wherever they want

nion leaders may have called off farmers' agitation in Haryana over Minimum Support Price (MSP) for sunflower seeds following the State government's decision to agree to their demand. However, they maintain that their protest for securing legal guarantees for MSP across the country will continue.

A legal guarantee for MSP was a major demand of the farmers mainly from Punjab, Haryana and western Uttar Pradesh during the year-long protest in 2020/2021 over the three Central farm laws. That protest ended when Prime Minister Narendra Modi announced on November 19, 2021, the repeal of those laws. Do the farmers understand the implications of this demand? MSP is a "minimum price" for any crop that the government considers as remunerative for farmers and hence deserving of "support". It fixes MSP for 23 crops grown in Kharif and Rabi seasons based on the recommendations of the Commission for Agricultural Costs and Prices (CACP) - a statutory body that works under the aegis of the Ministry of Agriculture & Farmers

The agencies of the government, such as the Food Corporation of India (FCI), buy wheat, rice/paddy, and coarse cereals, from farmers at the MSP. They also purchase other crops such as pulses and oilseeds which are procured by the National Agricultural Cooperative Marketing Federation of India Ltd (NAFED). However, not all crops for

which MSP is announced are purchased.

The procurement of food crops by state agencies is meant for giving to over 800 million beneficiaries under the National Food Security Act (NFSA) at a subsidized price of Rs 1/2/3 per kg. The excess of MSP, plus handling, storage and distribution costs over this price is paid as a subsidy by the government.

The government pays MSP to farmers under an 'executive order' introduced in the 1960s. It is not backed by any law. What would happen if the government decides to give a legal guarantee for MSP? The farmers would want it for all 23 crops for which MSP is fixed. The demand could be extended to cover all crops; in fact the entire agricultural pro-


Today, apart from government agencies, farmers' produce is picked up by private traders, processors, aggregators, exporters etc. When there is a law on MSP requiring that no purchase can be made at a price less than this minimum, they will all be scared of buying from farmers. Who will take the risk of landing in jail? A big chunk of private players (in fact, 'all') would desert farmers. The latter will be stuck with the crop only to rot in the fields. The ball doesn't stop here.

In view of a sizeable chunk of the crop produce not coming to the market (inevitable when there is no purchase/sale by private entities), there would be acute shortage resulting in an 'astronomical' rise in food prices and inflation. No measure fiscal or monetary aimed at reining in price rise would work. In such a scenario, farmers would expect the government/agencies to pick up their entire produce albeit at MSP pointing at the 'legal guarantee'. Can the

is next to impossible. The value of agricultural produce being about Rs 33,00,000 crore (estimated level for 2023-24), the Union government will have to spend nearly 75 per cent of its annual budget of Rs 45,00,000 crore (2023-24) on buying farmers' agri-produce. The remaining amount Rs 12,00,000 crore won't pay for bare essentials such as defence, maintaining law and order and payment of wages and salaries forget infrastructure, other development works and running welfare schemes.

Hundreds of thousands of crore are spent every year on subsidies for agricultural inputs such as fertilizers, irrigation, seeds, credit etc. All this goes towards helping farmers reduce production costs. With little money left after paying MSP, all this support would cease. Apart from financing, state agencies don't have the wherewithal to handle and store even the 'limited' quantities currently procured by them leading to huge wastages. One shudder at the very thought of a scenario where they will have to procure, handle and store the mountain of produce farmers offer for sale.

A related question is what would the state agencies do with this stuff? They can't hang on to it forever. The stock has to be offloaded to private trade sooner than later. This will entail huge losses due to sales at below MSP and the cost of handling and carthis will be a totally avoidable distraction for the government whose prime responsibility is delivering

on governance.
There will be other collateral damage. Under the Agreement on Agriculture (AoA) of the World Trade Organization (WTO), aggregate measurement support (AMS) – a WTO nomenclature for agricultural subsidies - is capped at 10 per cent of the value of agricultural production for a developing country. If a member country gives AMS in excess of 10 per cent, it is a violation. Already, with limited purchases from farmers, India is facing a daunting challenge at the WTO due to AMS exceeding the 10 per cent threshold. Imagine, what would happen options' to sell their produce when the government/agencies buy the entire produce from farmers albeit at MSP? Defending our subsidies at WTO would become


impossible. It is abundantly clear that a legal guarantee for the purchase of farmers' produce at MSP is a despicable idea. The government should not even look at it. True, farmers don't get a good price. But, a solution to that problem lies elsewhere. The state laws viz. APMC (Agricultural Produce Market Committee) Act permit the sale of agri – produce only at designated APMC mandi whose capacity is extremely limited. These mandis can't even cope with the quantities brought by large farmers even as small and marginal farmers who constitute 86 per cent of total landowning farmers are forced to come to private local markets where 'sales are legally barred'.

At APMC mandi, a cartel of licensed traders and commission agents (known as artisans in local parlance, their job is to facilitate transactions between farmer and the buyer) rules the roost. They make sure that the farmer doesn't get a fair price. At local markets also, this very cartel forces the more vulnerable farmers (read: small and marginal) to sell their crops at throwaway prices. Having come to the mandi travelling a long distance, the poor fellow has no option but to sell and get whatever is possible.

was to liberate hapless farmers from the stranglehold of this cartel by giving them 'multiple wherever they like. This is precisely what the three farm laws sought to do. Unquestionably, farmers would have got a good price probably even higher than MSP depending on the demandsupply scenario while artisans/traders needed to surrender a portion of their hefty margin. But, the latter masquerading as champions of the former spearheaded a year-long protest forcing Modi to withdraw the laws. The Supreme Court (SC) did its bit in letting this happen.

All that needed to be done

Meanwhile, Modi - government has taken several steps including an increase in MSP, hiking fertilizer subsidies and so on to help farmers but all this comes to naught as long as they remain strangulated. The irony is that these very saboteurs castigate the Prime Minister for not fulfilling his promise of 'doubling

# Titanic submersible search passes critical 96-Hour oxygen supply

The search for the missing **I** submersible on an expedition to view the wreckage of the Titanic passed the critical 96hour mark Thursday when breathable air could have run out, a grim moment in the intense effort to save the five people aboard.

The Titan submersible was

estimated to have about a fourday supply of breathable air when it launched Sunday morning in the North Atlantic but experts have emphasized that was an imprecise approximation to begin with and could be extended if passengers have taken measures to conserve breathable air.

And it's not known if they survived since the sub's disap-

Rescuers have rushed ships, planes and other equipment to the site of the disappearance. On Thursday, the US Coast Guard said an undersea robot sent by a Canadian ship had reached the sea floor, while a French research institute said a deep-diving robot with cameras, lights and arms also joined the operation.

Authorities are hoping underwater sounds might help narrow their search, whose coverage area has been expanded to thousands of miles twice the size of Connecticut and in waters 2 1/2 miles (4 kilometres) deep.

The Titan was reported overdue Sunday afternoon about 435 miles (700 kilometers) south of St. John's, Newfoundland, as it was on its way to where the iconic ocean liner sank more than a centu-

OceanGate Expeditions, which is leading the trip, has been chronicling the Titanic's decay and the underwater ecosystem around it via yearly voyages since 2021.By Thursday morning, hope was running out that anyone on board the ves-



sel would be found alive.

Many obstacles still remain: from pinpointing the vessel's location, to reaching it with rescue equipment, to bringing it to the surface — assuming it's still intact. And all that has to happen before the passengers' oxygen supply runs out.Dr. Rob Larter, a marine geophysicist with the British Antarctic Survey, emphasised the difficulty of even finding something the size of the sub — which is about 22 feet (6.5 metres) long and 9 feet (nearly 3 metres)

high.
"You're talking about totally dark environments," in which an object several dozen feet away can be missed, he said. "It's just a needle in a haystack situation unless you've got a pretty precise location."

The area of the North Atlantic where the Titan vanished Sunday is also prone to fog and stormy conditions, making it an extremely challenging environment to conduct a search-and-rescue mission, said Donald Murphy, an oceanographer who served as chief scientist of the Coast Guard's International Ice Patrol.

The passengers are also facing temperatures just above freezing. Meanwhile, newly uncovered allegations suggest there had been significant warnings made about vessel safety during the submersible's development. Broadcasters around the world started newscasts at the critical hour Thursday with news of the submersible. The Saudi-owned satellite

### **Explosion at restaurant** in China claims 31 lives

t least 31 people were killed Aand seven others injured when a massive cooking gas explosion ripped through a barbecue restaurant in northwestern China on the eve of the Drago Boat festival, official media reported on Thursday.
The blast happened at

around 8:40 pm on Wednesday on a busy street in the Xingqing District of Yinchuan, due to a leakage of liquefied petroleum gas (LPG) from the operating state-run Xinhua news agency reported on Thursday.

Nine people, including the owner of the restaurant, were

The explosion resulted in 38 casualties, with 31 people confirmed dead, while seven individuals, including one in critical condition, are currently receiving medical treatment, Ningxia Hui Autonomous Regional Committee of the ruling Communist Party of China (CPC) said.

The explosion took place on the eve of the two-day nationwide holiday of China's Dragon Boat festival beginning on Thursday. The restaurant was reportedly packed with a holiday crowd.

The blast caused heavy damage to the surrounding

buildings. Chinese President Xi Jinping on Thursday called for an all-out rescue and treatment of the injured and a safety overhaul after a barbecue restaurant in Yinchuan.

Police have detained nine persons, including the owner, shareholders and staffers of a barbecue restaurant. The regional government has frozen their assets, Xinhua reported.

According to local media reports, the restaurant was part of a well-known chain and covered two floors, with room for around 20 diners on the ground floor.

The more enclosed second floor had karaoke rooms, the Hong Kong-based South China Morning Post reported.

Barbecues are a popular dining style in northwestern China and it is likely that many of the restaurant's patrons were celebrating the start of one of the country's most popular festivals.

#### UN warns Taliban over restrictions on women

United Nations (AP): The UN envoy for Afghanistan warned the country's Taliban rulers Wednesday that international recognition as the country's legitimate government will remain "nearly impossible" unless they lift severe restrictions on women and girls' education and employment.

Roza Otunbayeva told the UN Security Council that the Taliban have asked to be recognized by the United Nations and its 192 other member nations, "but at the same time they act against the key values expressed in the United Nations Charter."

In her regular discussions with the Taliban, she said, "I am blunt about the obstacles they have created for themselves by the decrees and restrictions they have enacted, in particular against women and girls."

The Taliban seized power in Afghanistan in August 2021 as U.S. and NATO troops were in the final weeks of withdraw-

Bank of England hikes borrowing rates by more than expected

 $F^{\rm ears}$  that the British economy is heading for recession mounted sharply on Thursday after the Bank of England raised borrowing costs by more than anticipated, seeking to combat stubbornly high inflation with a hike that will hit borrowers hard, particularly homeowners who have to refi-

nance in the coming months.
On a busy day for central bank action in Europe, the Bank of England said its ninemember Monetary Policy Committee decided to lift its main interest rate by half a percentage point to a fresh 15-year high of 5 per cent.

All but two of the panel backed the half-point increase. The size of the bank's 13th hike in a row was somewhat of a surprise, with most economists predicting a smaller quarter-point increase.

Bank Gov. Andrew Bailey warned of further increases if inflation fails to show clear signs of heading down. "We are committed to

returning inflation to the 2 per cent target and will make the decisions necessary to achieve that," he said.

Clearly, rate-setters have been spooked by the failure of inflation in the UK to ease as fast as predicted.

Inflation has proven stickier than in other major economies, with many blaming the bank for being too slow to start raising borrowing rates and Britain's departure from the European Union, which has added to import costs.

Figures on Wednesday showed UK inflation unexpectedly holding steady at 8.7 per cent, fuelling concerns over the outlook for prices after predictions for a modest decline to 8.4 per cent. With wages rising

ruled on Thursday that Hungary flouted the bloc's laws and infringed on migrants' rights by forcing asylum seekers inside the country or at in Serbia and Ukraine. Hungary's anti-immigrant government has

taken a hardline on people entering the country since well over one million people entered Europe in 2015, most of them fleeing conflict in Syria. It erected border fences and forcefully tried to stop many from entering. After the COVID-19 pandemic outbreak in

2020, the government pushed through a law forcing people seeking international protection to travel to Belgrade or Kyiv to apply for a travel permit at its embassies there to enter Hungary. Only once back could they file their applications. The EU's executive branch, the European

Commission, took Hungary to the European Court of Justice (ECJ) over the law, insisting that the country had failed to fulfil its obligations under the 27-nation's blocs rules. The rules oblige all member countries to have common procedures for granting asylum.

People have the right to apply for asylum or other forms of international protection if they fear for their safety in their home countries, or face the prospect of persecution based on their race, religion, ethnic background, gender or other discrimination.

The ECJ ruled that by "making an application for international protection subject to the prior submission of a declaration of intent at a Hungarian embassy situated in a third country," the government in Budapest "has failed to fulfil its obligations", according to a court



Our job is only half done, having brought inflation within the target band," Reserve Bank Governor Shaktikanta Das opined while voting for the status quo in the key policy rates along with other five members of the rate-setting panel early this month.

It was for the second time in a row that the Monetary Policy Committee (MPC) headed by the Governor kept the short-term lending rate (repo) unchanged after continuously raising it since May

As per the minutes of the MPC meeting held from June 6 to 8, Das said India's macroeconomic fundamentals are strengthening and growth prospects are steadily improving and becoming broad-based.

Inflation, he said has eased and the external sector outlook has improved. Balance sheets of banks and corporates look resilient and healthy, thereby engendering twin balance sheet advantage for growth.

"Our job is only half done, having brought inflation within the target band. Our fight against inflation is not yet over. We need to undertake forward-looking assessment of the evolving inflation-growth outlook and stand ready to act, if situation so warrants.

"Beyond this and given the prevailing uncertainties, it is difficult to give any definitive forward guidance about our future course of action in a rate tightening cycle," he said as per the min-

### TRAI consultation on encouraging innovative tech, biz models via regulatory sandbox

Telecom regulator TRAI has floated a discussion paper on encouraging innovative technologies, services, use cases, and business models through a regulatory sandbox in the digital communication sector.

The consultation paper proposes a draft sandbox framework and seeks inputs from stakeholders on its various aspects. This draft sandbox frame-

work includes information on the goals and scope of the architecture, participant eligibility requirements, prerequisites for applicants, supporting materials needed with applications, and application evaluation cri-

Other elements include the application and approval process, waivers or modifications to the rules, validity period, revocation of permission, reporting, an oversight body, and funding of innovation for societal

"The Telecom Regulatory Authority of India (TRAI) has released a consultation paper on Encouraging Innovative Technologies, Services, Use Cases, and Business Models through Regulatory Sandbox in Digital Communication Sector," TRAI said in a statement.

Regulatory bodies in many countries have established sandbox frameworks for telecom tech innovation, TRAI said and explained that these frameworks allow testing new con-



granting exemptions, allowances, or time-bound exceptions.

These frameworks aim to promote regulators' desire for innovation with economic resilience and consumer protection. It is in this backdrop, that the telecom department asked TRAI to provide recommendations on the framework for the regulatory sandbox.

The authority approaches the issue with the aim to promote creativity and accelerate the uptake of cutting-edge technologies in the field of digital communications," TRAI said.

Emerging technologies like Artificial Intelligence, the Internet of Things, edge computing, and others are transforming and revolutionising the way in which people connect, interact, and access information.

According to TRAI, there is a need for providing an enabling environment for the development and deployment of novel technologies, ser-

vices, use cases, and business models to stay up with this dynamic environment.

The regulatory sandbox strategy has gained traction throughout the world as a way to encourage innovation across various industries.

A regulatory sandbox provides a regulated setting where companies and innovators can test their concepts, goods, and services while operating under fluid regulations.

"Regulatory Sandbox will help the startup ecosystem in the telecom industry by giving them access to the real-time network environment and other data so that they may test the reliability of new applications before releasing them on the market," TRAI

To provide the starting company with a single window for obtaining all clearances, the regulatory sandbox also seeks to encourage cross-sectoral collaboration for carrying out such tests by enlisting the help of other ministries and departments.

The consultation paper discusses some of the regulatory sandbox frameworks that are working in the digital communication sector globally and also details some of the frameworks working within the country in other sectors.

The last date for written comments on the draft sandbox framework is July 17, 2023, and for counter comments August 1, 2023.



### **ONGC links Panna** field with sub-sea pipeline, saves cost

PTI ■ NEW DELHI

State-owned Oil and Natural Gas Corporation (ONGC) on Thursday said it has linked Panna oilfield in the Arabian Sea to shore through a sub-sea pipeline, helping save USD 43,000 a day in cost that was previously incurred in transporting crude oil through

Panna field, which is part of ONGC's Bassein & Satellite (B&S) asset of western offshore, produces 9,600 barrels of oil per day. With "the successful linkage of Panna process platform with subsea pipeline", the company "has achieved a significant cost reduction of approximately USD 43,000 per day," ONGC said in a statement.

Oil from the field was previously transported through ships. Now it flows to shore through the sub-sea pipeline.

"The submarine pipeline connection minimizes the production downtime associated with tanker changeovers and eliminates demurrage charges during adverse weather conditions," it said.

he Indian contingent continued its medal rush at the Special Olympics World Summer Games, crossing the 50-medal mark here.



#### IOC banishes boxing governing body from Olympics, but sport will still be at Paris Games

The International Boxing Association was banished from the Olympic family on Thursday, ending a years-long dispute fuelled by defying advice and instructions from the IOC. Boxing, however, will keep its status as an Olympic sport at the 2024 Paris Games.

The International Olympic Committee voted to de-recognize the IBA at a specially called meeting - an outcome that was inevitable after being recommended two weeks ago by the executive board, a body chaired by IOC president Thomas Bach.

The vote was 69-1, with 10 members abstaining.

Boxing was never really in danger of being kicked out of the Olympics over the four years since the IOC suspended the sport's governing body in an effort to force changes.
"We highly value the sport

of boxing. We have an extremely serious problem with IBA because of their governance," Bach told IOC members during their online meeting.

The dispute centered on the IBA's management under presidents from Uzbekistan and Russia who the IOC disapproved of, its finances being backed by Russian state energy firm Gazprom, plus the integrity of bouts and judging.

"The boxers fully deserve to be governed by an international federation with integrity and transparency," Bach said.
The IOC is already oversee-

ing boxing competitions for the Paris Olympics without IBA involvement, as it did for the Tokyo Games in 2021.

Boxing can now be confirmed on the 2028 Los Angeles Olympic program, which the IOC and Bach withheld as leverage against IBA. Boxing is "guaranteed" to be in Los Ängeles, members were told

Thursday. The sport is good for Olympic business with broad

appeal - 25 different countries won boxing medals in Tokyo, with nine taking gold - and the IOC repeatedly said its problem was with boxing officials, not its athletes. "We appreciate boxing as one of the most global sports. We embrace the values of boxing," Bach said, praising the sport's "important social role promoting inclusion."

Boycott has lashed out at
Ben Stokes and Co. To Ben Stokes and Co. For getting "carried away with Bazball" and not making winning a priority, adding that England are in danger of reducing the Ashes to an exhibition series.

England, playing an aggressive brand of cricket under coach Brendon McCullum and skipper Stokes, were on the wrong side of the result as they suffered a twowicket loss in the Ashes opener in Edgbaston earlier this week.
"England are in danger of

reducing the Ashes to an exhibition," Boycott wrote in his scathing column for 'The Telegraph'.

"England have got carried

away with Bazball and seem to think entertaining is more important than winning. But England supporters want one thing more than anything else — to win the Ashes." The legendary cricketer said winning is more important than entertaining.
"Scoring fast runs, whacking

lots of fours and sixes is lovely. It is great. But only if England do not lose sight of the big prize which is to beat Australia. If at the end of the series Australia go home with the Ashes we will feel sick, regardless of how much we have been entertained."

Boycott claimed that the much-anticipated Ashes series between the two rivals would lose its importance if England don't play to win.

"If England are not playing to win then these Ashes Tests are not that important. They are only exhibition matches. They have got it back to front. It is not about entertaining and then winning. It is about winning first.

"By all means entertain but cricket is like chess. There are moments when you need to defend. Sometimes you need to be patient and accept it. "Do not just attack, attack,

attack. England need a bit of common sense and pragmatism. That is all that is required. They do not have to change being positive because they are a better side than

Australia and will win if they just show that common sense," he added. The former opener felt England were guilty of not capitalising on their chances despite dominating the match.
"England outplayed Australia

in nearly every session at Edgbaston but lost. When they are on top, be ruthless and not sloppy. We kept getting ahead of Australia and then letting them back in by being careless.
"They are in danger of letting

hubris be their downfall ... It would be sad if playing exciting cricket for a year is going to their heads. They gave Australia a get out of jail free card. I find that

silly."

Opting to bat, England declared their first innings at 393/8 despite Joe Root batting unbeaten at 118, raising eyebrows.

"The rule is to get as many runs as you can when the pitch is good before it deteriorates. England might have scored another 40-50 runs with Root on a hundred and Ollie Robinson, who can bat, but declared to get a wicket."

Boycott also questioned the home batters' all out approach in the second innings.

'When they batted in the second innings they went crazy. England were scoring at five and six an over but for some reason batsmen were trying to score at more than that and got themselves

'There were five: Ben Duckett, Root, Harry Brook, Jonny Bairstow and Moeen Ali. It was unneces-

Boycott, however, feels that this English side is better than its Australian counterparts and can go on to win the Ashes.

"Ben Stokes and Brendon McCullum have rightly received a lot of praise for the way they have changed the attitude around the England team but playing just one way is not using your brain. If we are more interested in praise than winning then we have it wrong.
"I and many ex-players think

this England team have the beating of these Aussies. But do not waste that talent and commitment by letting it go to your head."
