Can conduct CLAT in regional languages too, NTA tells HC

THE NATIONAL Testing Agency (NTA) has informed the Delhi High Court that it is in a position to conduct the Common Law Admission Test (CLAT) in English and other Indian Languages.

In an affidavit filed in response to a plea seeking the conduct of CLAT-2024 in regional languages along with English, the NTA has said it has a pool of experts and translators in a wide range of subjects for the preparation of question papers in multiple languages.

It said that it has been conducting workshops for test developers/ subject experts in batches of 35 to 40 experts to develop question banks for examinations.

"Accordingly, the Question Papers in respect of the Common Law Admission Test (CLAT)-UG can be translated into other Indian languages, such as Assamese, Bengali, Gujarati, Hindi, Kannada, Malayalam, Marathi, Odia, Punjabi, Tamil, Telugu, and Urdu and design/printing the requisite OMR Answer Sheet in the required quantity depending upon the number of candidates to be scheduled for the said Test," the agency has said.

"Hence, in principle, NTA would be in a position to conduct the CLAT Examination in English and other Indian Languages as mentioned above," it added.

At present, CLAT is held in English by the Consortium of National Law Universities. The HC had, during the previous hearing on September 1, directed the petitioner to implead the NTA as a respondent.

CLAT-2024 is scheduled for December. The matter is next listed on October 6.

The agency has, however, said that if CLAT has to be conducted by the NTA, the exam could possibly be held in the third or fourth week of January 2024, considering that a minimum time of four months is required for preparations.

The 100-bed Sanjay Gandhi Memorial Hospital, whose foundation stone was laid by ex-Prime Minister Indira Gandhi in 1982, has been in operation in Munshiganj of Amethi since 1989.

On Sunday, police registered a case of death by medical negligence against four employees of the hospital, including its chief ex-

ecutive officer, over the death of a 22-year-old woman.

The woman was admitted to the hospital on September 14 morning after she complained of a stomach ache. As her condition worsened before undergoing gallbladder surgery, she was referred to a private hospital in Lucknow where she died on September 16. The family of the woman alleged that she died because of an anaesthesia overdose at Sanjay Gandhi Memorial Hospital and an FIR was

registered on September 17. Taking cognizance of the inci-

dent, district health officials also ordered a probe and constituted a three-member team, led by Additional Chief Medical Officer. On September 18, the hospital's licence was suspended by district health officials, citing prima facie evidence of medical negligence.

"We are going to appeal against the decision in the court. We were asked for an explanation about the September 14 incident three months' time, but orders were issued to suspend the licence of the hospital in the next 24 hours. We are not denying the incident and there can be an inquiry into it. An FIR has already been lodged," Wing Commander (retd) Manoj Muttu, the administer of Sanjay Gandhi Memorial Trust, told *The Indian Express*. "My submission as the repre-

sentative of the Trust is that it is possible (of such an incident) even in government hospitals. But to close down the entire hospital with 450 staff, 600 nursing students, 200 paramedic students, without giving an opportunity to explain is justified under what rule? Therefore, we are going to make an appeal," Muttu said.

Chief Medical Officer (Amethi) Anshuman Singh said that while the hospital was served a notice seeking an explanation in three months, the decision to suspend the licence was taken after prima facie evidence of laxity was found in the preliminary inquiry.

"Such incidents happen, but

not only did they not conduct prior medical tests... but even after diagnosing the problem of the patient, they kept her for another 10-12 hours before referring her to another hospital leading to her death. Our inquiry found that doctors as well as the administration were guilty of negligence and recommended the cancellation of the hospital's licence. If they are not satisfied, then further inquiry can be conducted by a bigger team," Dr Anshuman Singh told The Indian Express.

Meanwhile, Congress leader KLSharma said criticised the government's decision. "While the law would do its work, the way the hospital was closed down is not right. The one who is guilty should be punished and not the entire organisation. The hospital has been serving the people of Amethi for decades and now a lock has been put on it. The hospital is not of the Congress, it caters to all," Sharma said.

District Congress leaders also submitted a memorandum to the district administration against the decision.

THE DIG of Bihar fire services has accused the director general of police(D-G) in the department of harassing her, allegedly after she pointed out anomaly in fire ten-

Dismissing the complaint by Home Guards and Fire Services DIG Anusuiya Ransingh Sahu's allegations in a letter to her, D-G Shobha Ahotkar accused the DIG of "insubordination" and said the allegations were made after she recommended departmental proceedings against Sahu.

In her complaint, Sahu, a 2005-batch IPS officer, stated that Ahotkar cancelled two other bids after she pointed out the huge difference between two lowest bid rates but accused the D-G of holding it against her.

Ahotkar wrote: "I shared a very good relationship with you from my date of joining (6 March 2023) home guards and fire services department till 21 March 2023...when you asked me [to] study some files. I detected a file

in which there were three bids of the same specifications for purchase of 138 fire brigade vehicles through three bids.... I noticed huge differences in lowest bid rates that could have caused a loss of Rs 6.5 crore to the state exchequer. As I could not speak to you, I sought innocent advice from a department official. But you took offence and reprimanded me,

which caused me mental agony.' She alleged in the letter that the D-G had threatened her with "stringent punishment". Sahu wrote: "Though the department cancelled two bids and saved Rs 6.5 crore loss to the government, you[Ahotkar]kept nursing ill-will against me. Even though I had been on medical leave, showcause notices were issued against me."

Sahu marked a copy of the mail to the chief secretary; additional chief secretary, Home; and the state DGP.

Denying the allegations made against her, Ahotkar told reporters: "The DIG has been making baseless allegations against me since I have recommended departmental action against her for insubordination and dereliction of duty."

AIADMK leader Sellur Raju, questioning his courage to echo Annadurai's views on Sanatan. Annadurai, Udhayanidhi noted, was disheartened by a section that believed in Sanatan.

Highlighting the recent inauguration of the new Parliament building, Udhayanidhi criticised the decision of inviting "Aadheenams" from Tamil Nadu, questioning their relevance to the Parliament.

His friend dead in road accident, MP tribal man beaten up with slippers by BJP youth leader

AVIDEO of an office bearer of BIP's youth wing allegedly hitting an elderly tribal man with slippers, next to the body of another tribal man who had died in an accident, has prompted outrage from the opposition Congress in Madhya Pradesh, which attacked the ruling BJP government for being

"anti-tribal". According to the police, the incident took place on September 18 after Bhoma Singh (60) was killed in an accident involving a motorcycle he was driving and a pickup truck. The pillion rider, Barnu Singh Marawi (57), was allegedly assaulted by the accused, Jaiganesh Dixit, the Anuppur (rural) mandal president of Bharatiya

Janata Yuva Morcha (BJYM). "A crowd had gathered and they started questioning the injured pillion driver, who was dazed and recovering. He was still in shock and could not answer them. Jaiganesh Singh and another accused, Jitendra Kushwaha, also questioned Marawi, and when he was unable to answer, they allegedly assaulted him. The accused have been detained and appropriate legal action is being

taken," said a senior police officer. A video of the incident went viral following which Dixit was removed from his post. District BJP yuva morcha president Ravindra Rathore, in a letter to the accused, wrote, "The said act done by you, which has gone viral on social media (and) due to which the image of the party has been tarnished,

comes in the category of gross indiscipline. Therefore, you are relieved from responsibility of the party's board president (Bharatiya Janata Yuva Morcha Anuppur Rural) with immediate effect."

The Congress attacked the state government and CM Shivraj Singh Chouhan over what they said were repeated attacks on tribals in the state. This incident comes after a tribal man in Sidhi was urinated on by a man with BJP links in July this year, which set off a political firestorm after which Chouhan washed man's feet.

In a post on social media website, X, Congress leader Kamal Nath wrote: "Shivraj Singh Chouhan ji, you cannot ignore this gruesome video. Next to the dead body of a tribal man in Anuppur district, a BJP leader is seen beating another tribal man with slipper. When you cannot stop atrocities on tribals, at least resign from post of CM. The hypocrisy of washing feet cannot atone for your cruel rule. You have not only made Madhya Pradesh number one in atrocities against tribals, but have also made state number one in level

of cruelty in such incidents." "Have you given license to BIP workers to commit atrocities against tribals? A tribal daughter and five family members are buried alive in Nemawar. In Neemuch, a tribal youth was tied to a vehicle and dragged to death. A tribal youth in Sidhi was urinated upon. And every time, the person committing atrocities against tribals is either a leader of BJP or someone associated with it," he wrote.

Rajasthan: Dalit singer apologises before panchayat with shoes on head, three held

DEEP MUKHERJEE JAIPUR. SEPTEMEBER 20

POLICE IN Rajasthan have arrested three people and several others are being questioned after a video of a Dalit 'katha vachak' (religious singer) from Chittorgarh district apologising to members of the Gujjar community by putting their shoes on his head went viral,

officials said. According to the police, the elderly Dalit man seen in the video has been identified as Dalu Salvi (70), a singer who performs in religious programmes. An FIR has been registered, naming 10 peo-

ple as accused on the basis of a complaint by Salvi after outrage by Dalit groups over the incident.

"Around five-six months ago, during a katha vachan (religious singing) event, Salvi had said some words which had enraged Gujjar community. Earlier this month, he had to appear in front of a panchayat of the community, where he apologised with shoes on his head," said Devendra Kumar, SHO, Parsoli police station, Chittorgarh.

According to the FIR, during his narration in the katha vachan event, Salvi had mistakenly said that a folk deity worshipped by the Gujjar community was the daughter of a Dalit man from the Salvi community.

He said that around a week ago, a person called him on his phone and abused him with casteist slurs over the incident. Thereafter, Salvi went to a caste panchayat of Gujjar community to resolve the issue, states the FIR.

An FIR under IPC sections 143 (unlawful assembly), 504 (intentional insult with intent to provoke breach of the peace) and 506 (punishment for criminal intimidation) along with sections of the SC/ST (Prevention of Atrocities) Act was registered on Tuesday after a memorandum was submitted by Dalit groups to the district administration.
